

FIELD NOTE DESCRIPTION 0.540 ACRES IN THE JOSEPH M. EVERETT SURVEY, ABSTRACT NUMBER 197, MONTGOMERY COUNTY, TEXAS

BEING a 0.540 acre tract of land situated in the Joseph M. Everett Survey, Abstract Number 197, Montgomery County, Texas, being all of that same called 0.540 acre tract described as Lot 59 of White Oak Forest (unrecorded subdivision) in instrument to Malcolm Wayne Hicks and Gloria Jean Hicks, recorded in Volume 1054, Page 936 of the Deed Records of Montgomery County, Texas (D.R.M.C.T.), said 0.540 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a ½ inch iron rod found in the southerly margin of Pine Circle, for the common northerly corner of said Lot 59 and that certain called 0.544 acre tract described as Lot 60 of said White Oak Forest in instrument to Jose G. Aguilar, Jr. and Lorenza Aguilar, recorded under Clerk's File Number 2020022871, Official Public Records of Montgomery County, Texas (O.P.R.M.C.T.), being the northwesterly corner and POINT OF BEGINNING of the herein described 0.540 acre tract, having a Texas State Plane Coordinate value of N: 10,037,785.51, E: 3,920,564.29, Texas Central Zone, (4203), grid measurements, from which a ½ inch iron rod found for reference bears South 86°13'31" West, 119.77 feet;

THENCE North 86°13'31" East, 92.91 feet, with the southerly margin of said Pine Circle, the northerly line of said Lot 59, to a ½ inch iron rod with cap stamped "TPS 100834-00" set for a point of curvature and beginning of a culde-sac of said Pine Circle, same being a point of curvature of the herein described 0.540 acre tract and beginning of a curve to the left:

THENCE Southeasterly, 30.24 feet, with the cul-de-sac of said Pine Circle, the northerly arc of said Lot 59 and said curve to the left, having a radius of 40.00 feet, a central angle of 43°19'21", and a chord that bears South 71°56'43" East, 29.53 feet, to a ½ inch iron rod with cap stamped "TPS 100834-00" set for the common northerly corner of said Lot 59 and that certain called 0.540 acre tract described as Lot 58 of said White Oak Forest, in instrument to David Warwick, recorded under Clerk's File Number 2012082840, O.P.R.M.C.T., being the northeasterly corner of the herein described 0.540 acre tract, from which a 1/2 inch iron rod with cap found for reference in the east quadrant of said cul-de-sac bears with a curve to the left, having an arc length of 62.75 feet, a radius of 40.00 feet, a central angle of 89°53'17", and a chord bearing North 41°26'58" East, 56.51 feet and from this point a 5/8 inch iron rod found for reference in the north quadrant of said cul-de-sac bears with a curve to the left, having an arc length of 63.44 feet, a radius of 40.00 feet, a central angle of 90°51'52", and a chord bearing North 48°55'37" West, 56.99 feet;

THENCE South 03°43'49" East, 185.82 feet, with the common line between said Lot 59 and said Lot 58, to a 5/8 inch iron rod found for the common corner of said Lot 59, said Lot 58, that certain called 25,886 square feet tract described as Lot 67 of said White Oak Forest, in instrument to Ryan Staggs, recorded under Clerk's File Number 2011084584, O.P.R.M.C.T., and that certain called 0.540 acre tract described as Lot 66 of said White Oak Forest, in instrument to Jan D. Sweppenhiser and Bonnie S. Sweppenhiser, recorded under Clerk's File Number 2015082257, O.P.R.M.C.T., being the southeasterly corner of the herein described 0.540 acre tract;


THENCE South 86°00'14" West, 120.34 feet, with the common line between said Lot 59 and said Lot 66, to a ½ inch iron rod found for the common corner of said Lot 59, said Lot 66, that certain called 0.544 acre tract described as Lot 65 of said White Oak Forest, in instrument to Kyle Collier and Blakely Graham, recorded under Clerk's File Number 2005080375, O.P.R.M.C.T., and said Lot 60, being the southwesterly corner of the herein described 0.540 acre tract;

THENCE North 03°43'49" West, 197.27 feet, with the common line between said Lot 59 and said Lot 60, to the **POINT OF BEGINNING** and containing a computed area of 0.540 acres of land within this Field Note Description.
