

A TRACT OF LAND being the South ½ of Lot 5, in Block 73, in the City of Galveston, Galveston County, Texas, according to "Plan of the City of Galveston by William Sandusky, 1845", a plat in common use, said TRACT OF LAND containing 0.120 acre (5,217 square feet) of land and being further described by metes and bounds as follows:

BEGINNING at a found 5/8 inch diameter steel reinforcement bar with plastic cap (IR w/cap) at the southwest corner of Lot 5 and the southeast corner of Lot 4, in the northerly line of a 20 foot alley;

THEN N 16° 15' W along the common line of Lots 4 and 5, 60.00 feet to a set ½" IR at the midpoint of the westerly line of Lot 5;

THEN N 73° 45' E, 42.83 feet to a found IR w/cap at the midpoint of the easterly line of Lot 5;

THEN S 16° 15' E along the common line of Lots 5 and 6, 60.00 feet to the southeast corner of Lot 5 and the southwest corner of Lot 6, in the northerly line of the 20 foot alley, from which a set  $\frac{1}{2}$ " IR bears S 16° 15' E, 1.00 foot, being a one foot offset in the alley;

THEN S 73° 45' W along the alley, 42.83 feet to the POINT OF BEGINNING, containing 0.059 acre (2,570 square feet) of land.

Plat and bearings refert to "Plan of City of Galveston by William Sandusky, 1845".

The foregoing legal description was prepared in conjunction with the survey plat attached and describes the same property as shown in the vesting deed, recorded in File #2013064696, in the Office of the County Clerk of Galveston County, Texas and is the same property described in Schedule A of title insurance commitment GF #1410735 bearing an effective date of 9/16/21 as prepared by Stewart Title Co..
