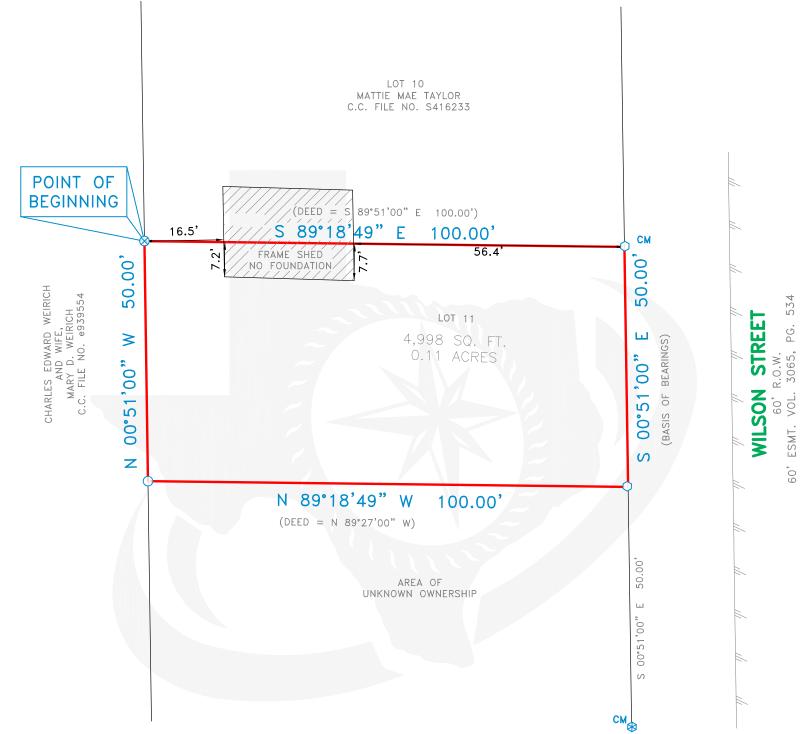

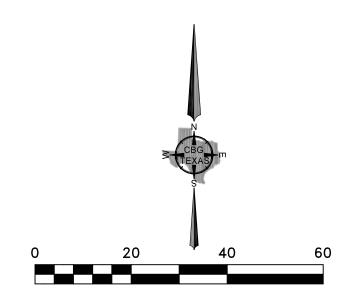
BEGINNING at a 1/2 inch iron rod set for corner with yellow plastic cap stamped "CBG Surveying" for corner, said corner being the Southwest corner of that tract of land conveyed to Mattle Mae Taylor, by deed recorded in County Clerk's File Number S416233, Official Public Records of Harris County, Texas, same being the Northwest corner of herein described tract, and lying along the East line of that tract of land conveyed to Charles Edward Weirich and wife, Mary D. Weirich, by deed recorded in County Clerk's File Number e939554, Official Public Records of Harris County, Texas:

THENCE South 89 degrees 18 minutes 49 seconds East, along the South line of said Taylor tract, a distance of 100.00 feet to a 1 inch iron pipe found for corner, held as a controlling monument, said corner being the Southeast corner of aforesaid Taylor tract, and lying along the West line of Wilson Street (60 foot right-of-way);

THENCE South 00 degrees 51 minutes 00 seconds East, along said West line of Wilson Street, a distance of 50.00 feet to a 1 inch iron pipe found for corner, from which a 1/2 inch iron pipe found bears South 00 degrees 51 minutes 00 seconds East, a distance of 50.00 feet for witness, held as a controlling monument;

THENCE North 89 degrees 18 minutes 49 seconds West, departing said West line of Wilson Street, a distance of 100.00 feet to a 1/2 inch iron rod found for corner with yellow plastic cap stamped "CBG Surveying" for corner, said corner lying along the aforementioned East line

THENCE North 00 degrees 51 minutes 00 seconds West, along said East line of Weirich tract, a distance of 50.00 feet to the POINT OF BEGINNING and containing 4,998 square feet or 0.11
