BEGINNING: At a 1/2" iron rod with cap stamped "Hoover" found in the south right of way line of English

Crossing Road, (a variable width right of way), for the northeast corner of a Lot 1,

Clearwater Canyon Ranch, and the northwest corner of Lot 2 and This Tract and the POINT

OF BEGINNING;

THENCE: S 78°03'55" E, 332.00 feet, with the south line of English Crossing Road and the north line

of Lot 2 and This Tract to a ½" iron rod with cap stamped "Hoover" found for the northwest corner of Lot 3, Clearwater Canyon Ranch and the northeast corner of Lot 2 and This Tract;

THENCE: S 11°56'05" W, 770.42 feet, departing the south line of English Crossing Road, with the

west line of Lot 3 and the east line of Lot 2 and This Tract, to a ½" iron rod found in the northeast line of a 30 Acre Tract described in deed to Kimberly A. Gardiner and Arthur G. Gardiner of record in Volume 1191, Page 597, Official Public Records, Bandera County, Texas, for the southwest corner of Lot 3 and the southeast corner of Lot 2 and This Tract;

THENCE: N 43°51'42" W, 401.34 feet, with the northeast line of the 30 Acre Tract, and a southwest

line of Lot 2 and This Tract to a ½" iron rod found for the southeast corner of Lot 1 and the

southwest corner of Lot 2 and This Tract;
