Metes and Bounds Description

Being a tract of land containing 0.3751 acres (16,339 square feet), situated in the Angier, Hall and Bradley Survey, Abstract 6, Brazoria County, Texas, being part of Lots 11 and 12, in Block 5, of Oak Manor Estates, Section 2, a subdivision recorded ii Volume 11, Page 7, of the Plat Records of Brazoria County, Texas, being that same tract of land as recorded under County Clerk's File No. 2006054735, of the Official Records of Brazoria County, Texas. Said 0.3751-acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a point for the northeast corner of said Lot 11 and the northwest corner of said Lot 12 for the northwest corner of the said tract herein described;

THENCE South 60°47'00" East, a distance of 200.75 feet to a point for the northeast corner of said Lot 12 and the most northerly corner of Lot 13 in said Block 5 for the northeast corner of the said tract herein described;

THENCE South 77°13'08" West, a distance of 113.32 feet along the common side line of said Lots 12 and 13 to ½-inch iron rod found at an angle point of the said tract herein described;

THENCE South 89°23'31" West, a distance of 35.00 feet to ½-inch iron rod found at an angle point of the said tract herein described;

THENCE South 73°35'54" West, a distance of 48.31 feet to an iron pipe found for corner in the northeast right-of-way line of Shady Oak Court (60 feet wide) for the southeast corner of the said tract herein described;

THENCE along a curve to the left with a radius of 60.00 feet, an arc length of 62.41 feet (called 62.28 feet), a chord bearing of North 60°59'45" West (called North 60°52'56" West) and a chord length of 59.63 feet (called 59.53 feet), to an iron pipe found for corner for the southwest corner of the said tract herein described;

THENCE North 32°28'42" East, across said Lot 11 in Block 5 for a distance of 128.26 feet to the POINT OF BEGINNING and containing 0.3751 acres (16,339 square feet), more or less.
