THENCE with the non-fenced North line of the Levy "12.27 acres", same being a line of the Brew "12.27 acres", the South line of the Homer Simpson "12.27 acres" (recorded in Volume 321 Page 512 LCDR) and the South line of the Friendship Church "1 acre" (recorded in Volume 402 Page 752 LCDR), North 89°-15'-11" East a distance of 944.60 feet to the Northeast corner of the Levy "12.27 acres" in the Northeast side of County Road 3241; found a ½" steel rod (no cap) bearing South 57°-06'-58" West 2.95 feet; found an electric pole (cut off) bearing South 82°-12' West 44.78 feet;
