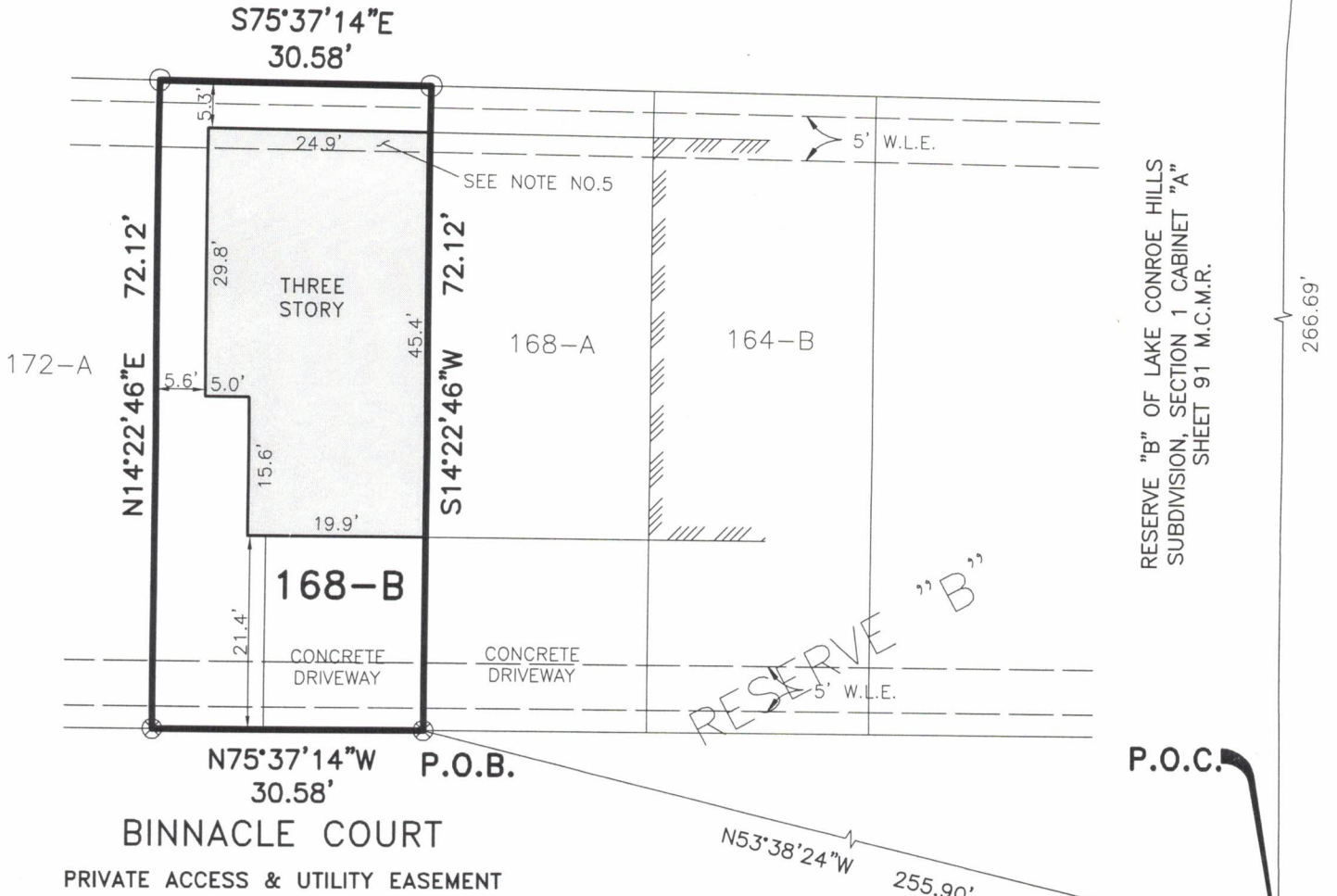

BEING A PARCEL CONTAINING A COMPUTED AREA OF 0.0506 OF AN ACRE OF LAND SITUATED IN THE TIMOTHY CUDE SURVEY, ABSTRACT NO. 12 OF MONTGOMERY COUNTY, TEXAS AND BEING OUT OF AND A PART OF RESERVE "B" OF LAKE CONROE HILLS SUBDIVISION, SECTION 1 ACCORDING TO THE PLAT THEREOF RECORDED IN CABINET "A", SHEET 91 OF THE MAP RECORDS OF MONTGOMERY COUNTY, TEXAS. SAID 0.0506 ACRE PARCEL BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS WITH ALL BEARINGS REFERENCED TO SAID PLAT OF LAKE CONROE HILLS SUBDIVISION AS FOLLOWS:

COMMENCING FOR REFERENCE AT A 5/8 INCH IRON ROD FOUND MARKING THE SOUTHEAST CORNER OF SAID RESERVE "B" ALSO BEING THE NORTHEAST CORNER OF BLOCK 8 OF SAID LAKE CONROE HILLS SUBDIVISION;

THENCE, NORTH 53 DEGREES 38 MINUTES 24 SECONDS WEST, A DISTANCE OF 255.90 FEET TO AN "X" SET IN CONCRETE FOR THE POINT OF BEGINNING OF THE HEREIN DESCRIBED PARCEL;

THENCE, AROUND THE PERIMETER OF THE HEREIN DESCRIBED PARCEL, THE FOLLOWING FOUR (4) COURSES:

NORTH 75 DEGREES 37 MINUTES 14 SECONDS WEST, A DISTANCE OF 30.58 FEET TO AN "X" SET IN CONCRETE FOR THE SOUTHWEST CORNER;

NORTH 14 DEGREES 22 MINUTES 46 SECONDS EAST, A DISTANCE OF 72.12 FEET TO A 5/8 INCH IRON ROD WITH PLASTIC CAP SET FOR THE NORTHWEST CORNER;

SOUTH 75 DEGREES 37 MINUTES 14 SECONDS EAST, A DISTANCE OF 30.58 FEET TO A 5/8 INCH IRON ROD WITH PLASTIC CAP SET FOR THE NORTHEAST CORNER;

SOUTH 14 DEGREES 22 MINUTES 46 SECONDS WEST, A DISTANCE OF 72.12 FEET TO THE POINT OF BEGINNING AND CONTAINING A COMPUTED AREA OF 0.0506 OF AN ACRE OF LAND.
