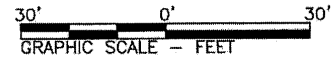


GENERAL NOTES

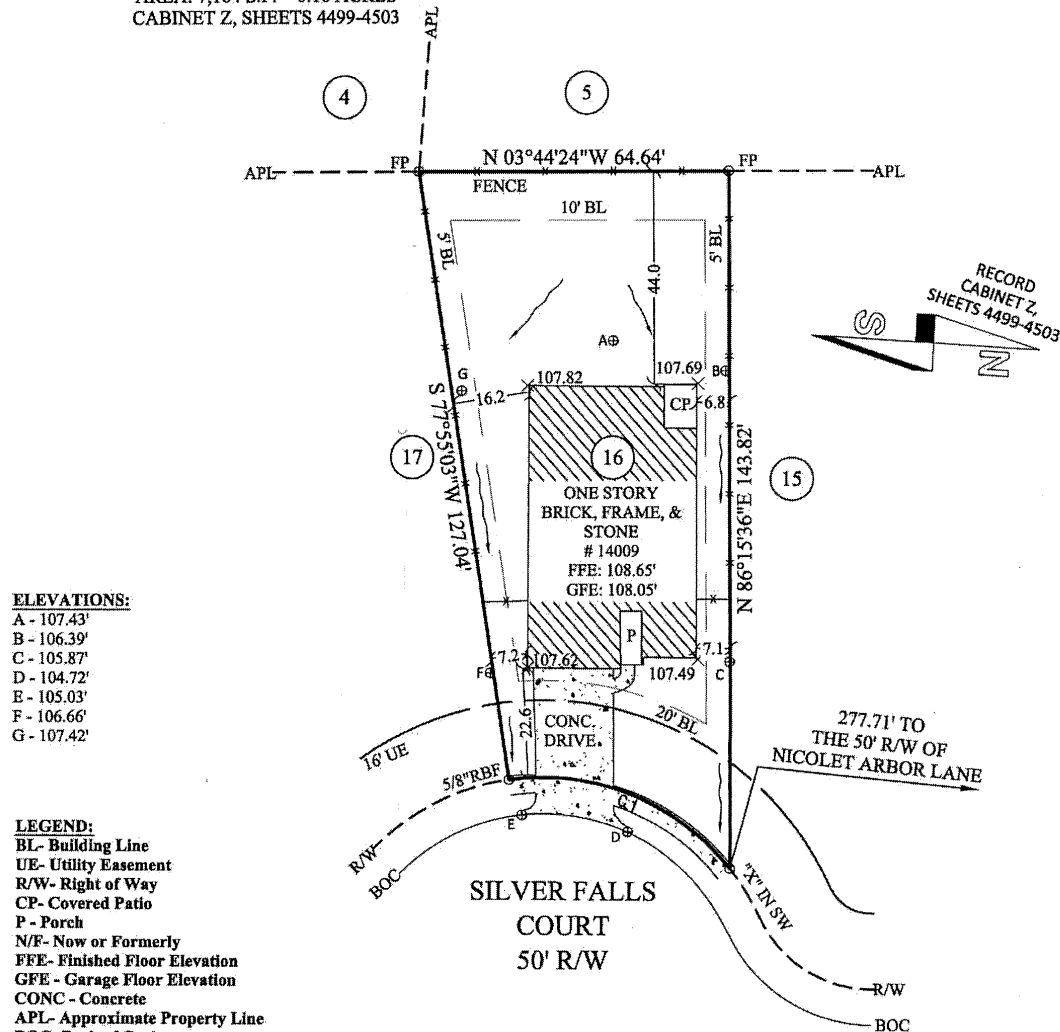

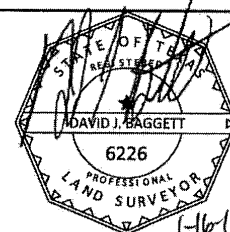
