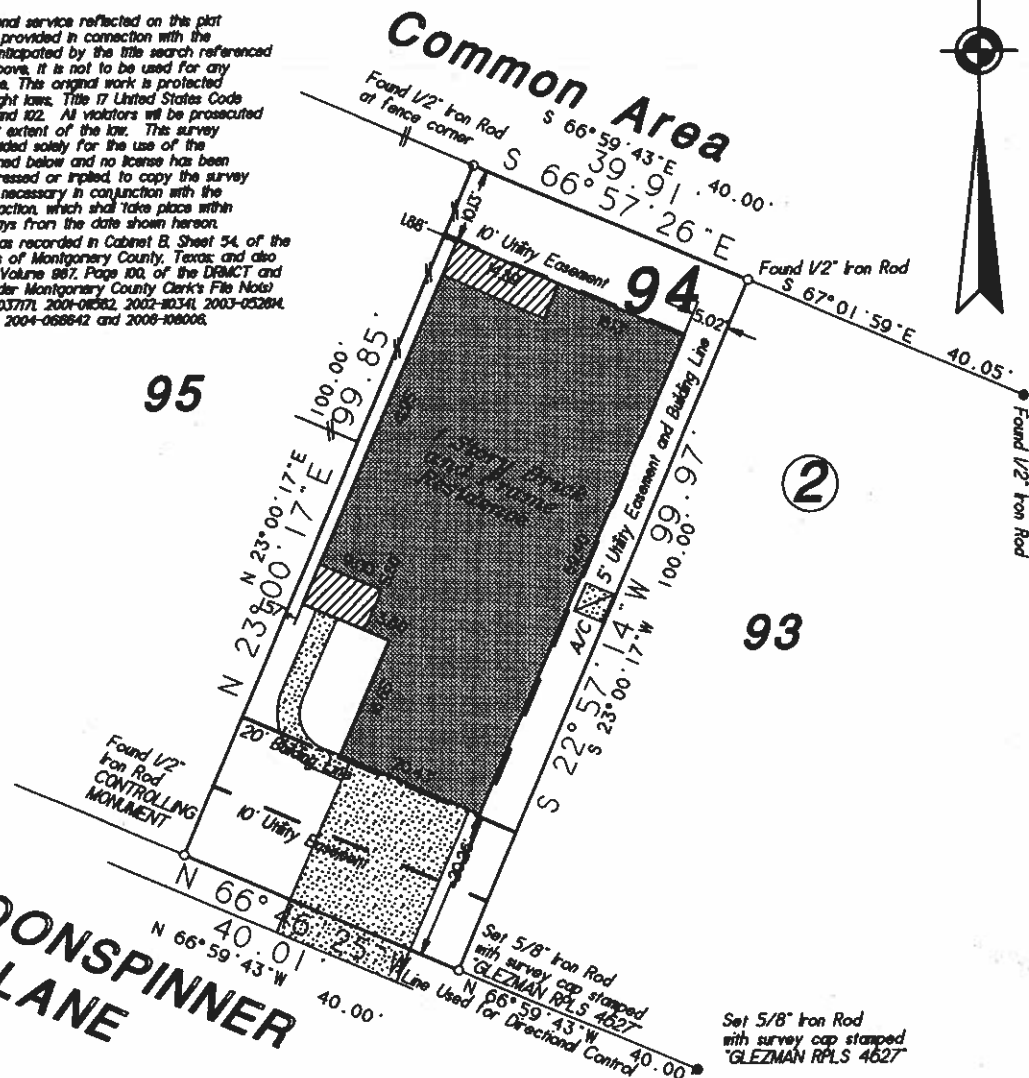


NOTES:
