On January 18, 2021, we conducted a foundation evaluation on the above referenced structure. Our purpose was to determine the extent of movement and to recommend corrective actions, if needed.

# **Clients Goal/Request:**

Client would like to determine if the foundation is preforming within tolerances level.

# **General Property Description**

This single-story house can generally be categorized by the following:

Foundation:Reinforced Slab on GradeFraming:WoodExterior:Brick/WoodRoofing:CompositionGarage:AttachedAge:51

#### Observations

Based on our visual observations and elevation measurements taken at the time of our inspection, the foundation **HAS** experienced movement exceeding generally accepted industry tolerances for residential construction. The items listed below provide visual observations on the condition of the structure, foundation, and property.

- There are large trees on this and the surrounding properties. (Pictures #1, 2, 3, and 4)
- There are visible cracks in the exterior brick of the home. (Picture #5)
- There are visible cracks in the interior sheetrock of the home. (Picture #6)
- There are visible cracks in the interior slab of the home. (Pictures #7 and 8)
- There are visible cracks in the interior slab of the garage. (Pictures #9 and 10)

- We recommend installing piers/pilings per our drawing.
- Review and perform our home owner foundation maintenance program.
