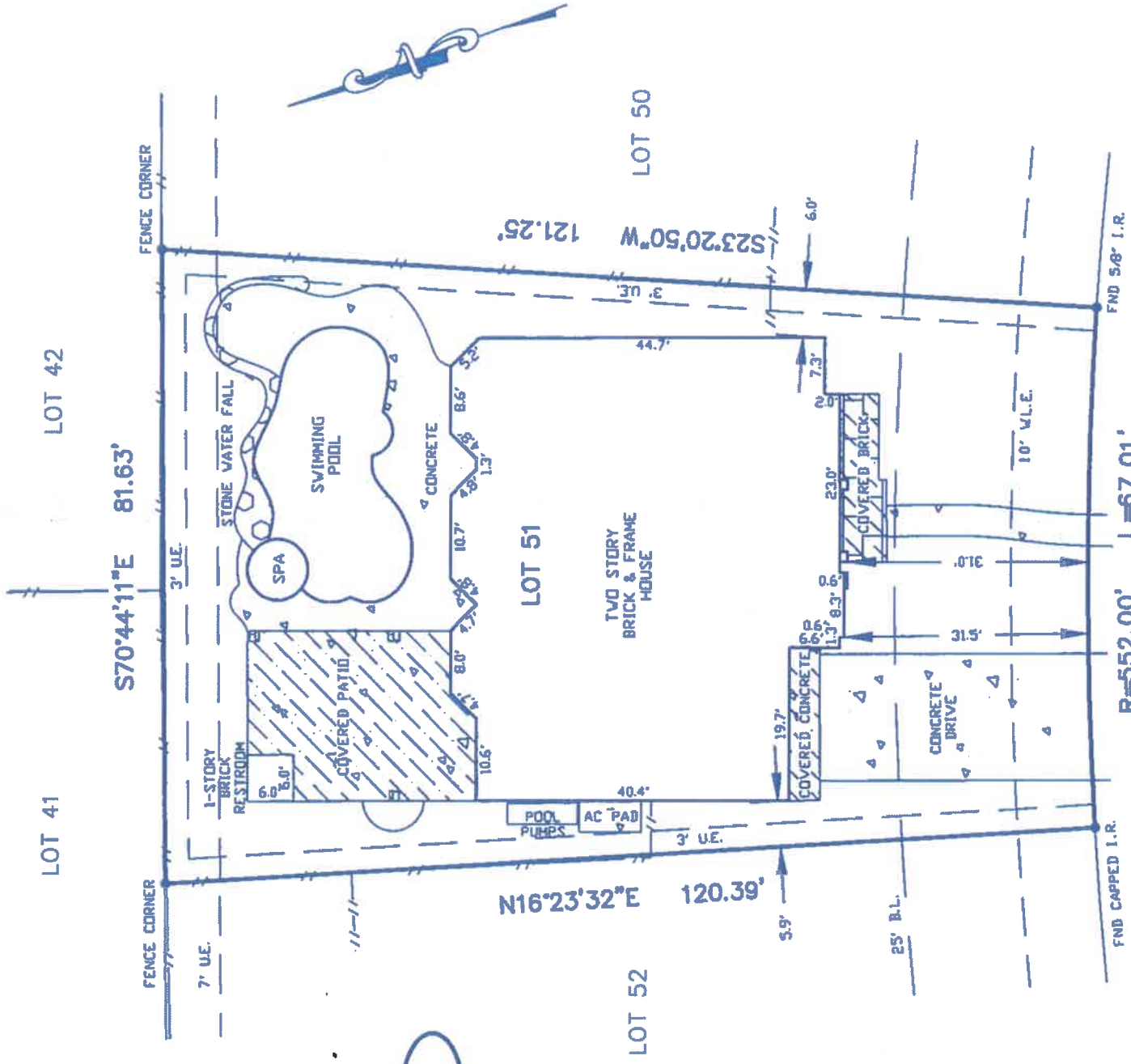


This property IS NOT located in the 100 year flood plain & is in insurance rate map zone X, as per map 48201C.0193L dated 06-18-07.

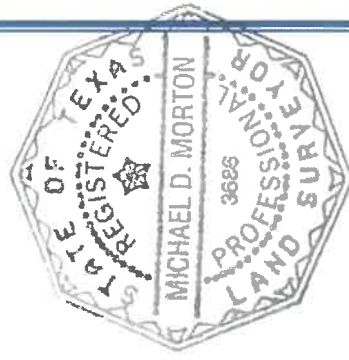
