Hargrove gas logs are made with refractory materials. Each log is hand-finished to assure the most realistic, detailed log available. The gas log burner system is designed to burn like wood, with a smoky flame. For this reason, the gas log set must be burned only in a fully vented, non-combustible fireplace with the <u>damper completely open</u> and the chimney free of any obstructions or restrictions. The fireplace must be designed and approved to burn wood.

The realistic yellow flame produces carbon monoxide and soot. Under normal conditions, these products are exhausted up the chimney. If fumes or soot, from the gas burning, are evident in the room when the damper is fully open it indicates that the fireplace draft is defective. Do not operate your gas log set until the fireplace draft is corrected.

After allowing the logs to cool for at least one hour, the set can be burned for any length of time.


WARRANTY

Please use this manual in conjunction with your main manual to properly assemble your built-in grill. Refer to the main manual for operating, cleaning, and maintenance instructions. This grill is designed for NON-COM-BUSTIBLE enclosures only, and must be installed and serviced by a qualified installer to local codes.

BUILT IN PROPANE GAS HOOK-UP: The piping up to the gas grill is the responsibility of the installer and piping should be located as shown in the built-in instructions. Do not use hose to connect the unit. It must be connected with either rigid pipe, copper tube or an approved flexible metal connector. The installation must comply with CAN B149.1 Natural Gas and Propane installation code in Canada, or to the National Fuel Gas code, ANSI Z223.1 in the United States. The minimum recommended piping size is NPS 1/2" for rigid pipe, and 1/2" OD for copper tubing (based on a 20 ft run). Longer runs may require larger sizes to conform with local codes or to conform with CAN B149.1. Propane Gas Installation Code in Canada or to the National Fuel Gas Code, ANSI Z223.1 in the United States. The gas supply must be connected to the 3/8" flare fitting located under the right hand side of the control panel. If installing a side burner, a separate line must be branched off to the side burner unit and enter the side burner opening at the specified location. If the enclosure is to house a propane cylinder, the tank portion of the enclosure must be ventilated according to local codes, and must not have communication with the cavity used to enclose the gas grill. A propane tank can not be stored below the gas grill.

The gas supply must be connected to the 3/8" flare fitting located under the right hand side of the control panel. If installing a side burner, a separate line must be branched off to the side burner unit and enter the side burner opening at the specified location.

Built in units are supplied with a drip pan which holds only a minimal amount of grease. To prevent grease fires, the pan must be cleaned after each use.
