BEING 27.611 ACRES OF LAND situated in the Ramon de la Garza Survey, Abstract 33, Houston County, Texas and being all of that certain called 27.667 acre tract described as "Tract #1B" in a deed to John Lewis Dickson as recorded in Instrument No. 024726 of the Official Records of Houston County, Texas, and being more particularly described by metes and bounds as follows:

BEGINNING at a $\frac{1}{2}$ " iron rod found for the north corner of said called 27.667 acre tract and the east corner of the residue of that certain called 50.13 acre tract conveyed to Harvey Huff, et ux as recorded in Volume 510, Page 430 of the Deed Records of Houston County, Texas, same being in the southwest line of that certain called 29.50 acre tract described as "Tract One" in a deed to P.F. Partners as recorded in Volume 1052, Page 904 of the Official Records of Houston County, Texas, from which a $\frac{1}{2}$ " iron rod found for the west corner of said called 29.50 acre tract and the south corner of that certain called 29.50 acre tract conveyed to James R. Ferguson, et ux as recorded in Instrument No. 013282 of the Official Records of Houston County, Texas bears N 34°51'08" W – 121.55';

THENCE South 33°59'54" East with the northeast line of said called 27.667 acre tract and the southwest line of said P.F. Partners called 29.50 acre tract a distance of 472.65 feet to a ½" iron rod with cap (RPLS 5748) set for the east corner of said called 27.667 acre tract and the north corner of that certain called 21.867 acre tract described as "Tract No. One" in a deed to Albertine McDaniel as recorded in Volume 540, Page 310 of the Deed Records of Houston County, Texas, from which a ½" iron rod with cap (RPLS 5980) found for the south corner of said P.F. Partners called 29.50 acre tract and the west corner of the residue of that certain called 101.6 acre tract described as "Tract Two" in a deed to Franklin D. Wagner as recorded in Instrument No. 010101 of the Official Records of Houston County, Texas bears S 33°59'54" E – 112.75';

THENCE South 52°41'35" West with the southeast line of said called 27.667 acre tract and the northwest line of said called 21.867 acre tract a distance of 2539.23 feet to a point in the centerline of County Road No. 2190 for the south corner of said called 27.667 acre tract and the west corner of said called 21.867 acre tract, from which a $\frac{1}{2}$ " iron rod with cap (RPLS 5748) set for reference bears N 52°41'35" E – 48.59';

THENCE North 38°16'59" West with the southwest line of said called 27.667 acre tract and the centerline of said County Road No. 2190 a distance of 468.99 feet to a point for corner in same for the west corner of said called 27.667 acre tract and the south corner of the residue of said called 50.13 acre tract, from which a $\frac{1}{2}$ " iron rod found for reference bears N 52°37'40" E – 17.42';

THENCE North 52°37'40" East with the northwest line of said called 27.667 acre tract and the southeast line of the residue of said called 50.13 acre tract a distance of 2574.50 feet back to the PLACE OF BEGINNING and containing 27.611 ACRES OF LAND.
