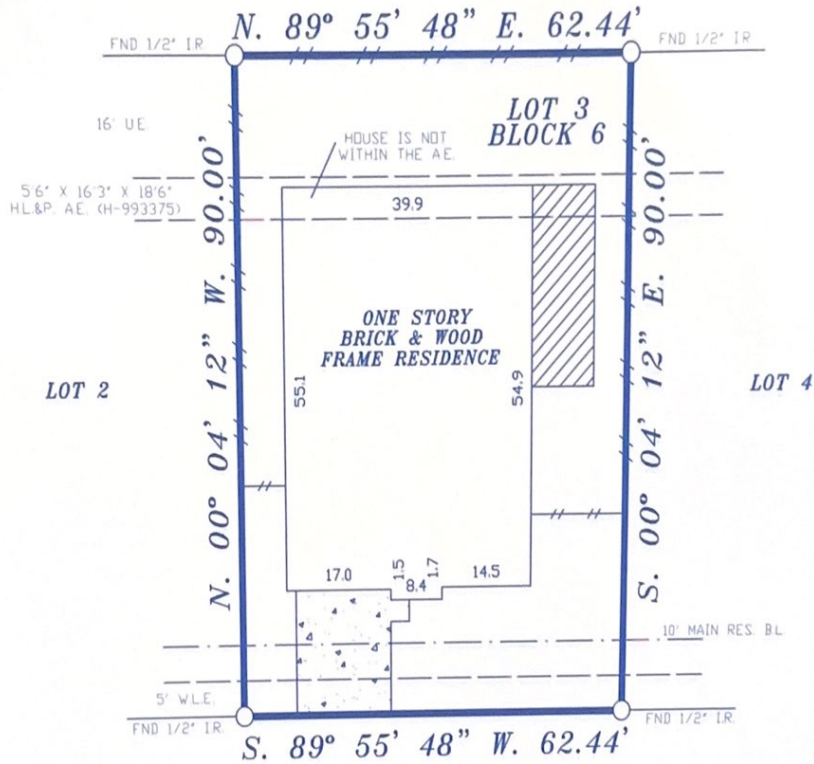


ACREAGE
