A TRACT OF LAND out of Lot 39, Section 2, TRIMBLE AND LINDSEY SURVEY of Galveston Island, Galveston County, Texas, containing 3.135 acres (136,540 square feet) of land and being further described by metes and bounds as follows;

BEGINNING at a ½ inch diameter steel reinforcement bar (1/2" IR) set at the intersection of the South line of Stewart Road (100 foot width) and the East line of 8 Mile Road (60 foot width), being S 25° 00' E, 60.2 feet and N 65° 00' E, 107.3 feet feet from the northwest corner of Lot 39;

THEN N 66° 10' E (called N 65° 31' E) along Stewart Road, 222.02 (called 222.7) feet to a 1" steel pipe (1" IP) found at the intersection with the East line of Lot 39;

THEN S 25° 00' E, 607.59 (called 607.69) feet to a found 1" IP in the North line of Gaff Toppers Subdivision #1, recorded in Volume 10, Page 41, in the Office of the County Clerk of Galveston County, Texas;

THEN S 65° 00' W along Gaff Toppers Subdivision #1, 226.43 (called 225.88) feet to a 1" IP found in 8 Mile Road;


THEN N 24° 35' W, 611.87 feet (called N 24° 42' W, 609.70 feet) along 8 Mile Road to the POINT OF BEGINNING, containing 3.135 acres (136,540 square feet) of land.

This Field Note description has been prepared in conjunction with the survey plat attached. Bearings are assumed along the East, line of Lot 39. Distances are true ground distances.


