BEGINNING in the North boundary line of the above referred to 105.39 acre tract, at the Southwest corner of that certain 9.871 acre tract which was conveyed, as Exhibit B, from Leroy Hardy, et al, to William Franklin Thornton, et al, by deed dated June 27, 1997 and recorded in Volume 598, on Page 17 of the Deed Records of Trinity County, Texas, same being the Southeast corner of that certain 37.2 acre tract which was conveyed, as Exhibit A - First Tract, from Leroy Hardy, et al, to William Franklin Thornton, et al, by deed dated June 27, 1997 and recorded in Volume 598, on Page 17 of the Deed Records of Trinity County, Texas, a concrete monument found for corner from which a fence corner bears N 00° 25' E 5.44 feet, a fence corner bears N 02° 53' E 1.45 feet, and a utility pole bears N 05° 13' W 13.28 feet;

THENCE N 89° 16° 36° E with the North boundary line of the above referred to 105 39 acre tract, common with the South boundary line of said 9 871 acre tract, 383 99 feet to a %" iron pipe set for corner therein from which a %" iron pipe found, the Northeast corner of the above referred to 105.39 acre tract, bears N 89° 16' 36° E 215.00 feet and a 12° Hickory bears 5 86° 27° W 49.10 feet.

THENCE S 00° 43' 24" E severing the above referred to 105.39 acre tract, 350.99 feet to a W' iron pipe set for corner.

THENCE 5 89" 19' 08" W severing the above referred to 105.39 acre tract, 624.6% feet to a '%" iron pipe set for corner;

THENCE N 00° 03° 57° W severing the above referred to 103.39 acre tract, 349.98 feet to a 5° tron pipe set for corner in the North boundary line thereof, same being the South boundary line of said 37.2 acre tract, from which an exte found, the Northwest corner of said 105.39 acre tract, bears 5.89° 56° 03° W 1043.06 feet.
