Herbicide season is upon us. The first step in the reforestation of your 92 acre tract will be the aerial application of herbicide on the clear cut areas to ensure the control of the hardwood sprouts and hardwood brush that is now growing on the site. The application of the herbicide should happen in the next few weeks. The planting will follow during the months of December through March of 2007. The Red River representative recommended a mixture of 28 oz. Chopper Gen2, 2 qt. Razor, 3 oz. Oust Extra, plus 32 oz. surfactant in 10 gallons of water per acre. This mix of herbicide will control the hardwood sprouts that are gaining a foothold on the site. An additional effect will be the control of grass through most of the next growing season. This chemical site preparation will be all that is necessary to prepare your tract for planting. The cost of this 44-acre project will be \$4,554.00.

CJT & Associates will be contracting with Red River Specialties to apply the herbicide on one contract that covers all of the CJT clients. This procedure will streamline the amount of paperwork necessary before the field- work begins. Additionally, a check, <u>made payable to C J T & Associates</u>, in the amount of full payment for the herbicide application will be placed in the client file and held in the CJT offices until the herbicide has been applied and invoiced by Red River Specialties.

I do not have a schedule of the date that this project will commence. I probably won't know until a day or two before it is flown, but it will be conducted early this year. The chemical companies assure us that we will get the full effect of the herbicide as long as the trees have more than fifty % of their leaves.
