**Previous Roof Repairs** – Within the past year, the HOA repaired and sealed all skylights and repaired the flat roof and gutters in the master bedroom. All waterproofing has been completed, the gutters have been covered to prevent debris accumulation, and the sheetrock and insulation had been replaced.

**Previous Other Structural Repairs** – The subfloor on the first level has been leveled and the outside of the unit has been waterproofed prior to new tile floor installation

**Improper Drainage** – Yes. Was remediated (French drain added) by the HOA during Hurricane Harvey and prior to our purchasing of this property.

**Water Damage Not Due to a Flood Event** – There was significant water damage caused by leaking pipes. All plumbing and sheetrock has been repaired, as appropriate, by a licensed contractor.

\*A single blockable main drain may cause a suction entrapment hazard for an individual.

**Previous water penetration into a structure on the Property due to a natural flood event** – Previous seller disclosed water seepage under front door during Hurricane Harvey. This was remediated by the HOA by adding and maintaining the French drain. This was further proactively remediated by the current owner by waterproofing the exterior of the house to the foundation by a licensed contractor.
