The drainage of septic tanks into road, street, alley, or other public ditches, either directly or indirectly, is strictly prohibited.
 Drainage structures under private driveways shall have a net drainage opening area of sufficient size to permit the free flow of water without backwater, and shall be a minimum of one and there quarters (1-3/4) square feet (16 disanteet) pipe culvert).

Further, I do hereby declare that all parcels of land designated as lots on this plat are originally intended for the construction of residential dwelling units thereon and shall be restricted for some under the terms and conditions of such restrictions filed separately, unless otherwise noted.
