PROPOSAL AND CONTRACT

E, GULF FOUNDATION, DO HEREBY SUBMIT SPECIFICATIONS AND ESTIMATES TO FURNISH LABOR, EQUIPMENT ID MATERIALS TO PERFORM THE FOLLOWING:

WE WILL INSTALL /8 CONCRETE PIERS OF THE FOLLOWING SIZE AND SPECIFICATIONS.

- A. PIERS WILL BE DRILLED TO A DEPTH OF 10 TO 12 FT. DEPENDING ON THE SOIL CONDITIONS.
- B. PIERS WILL BE 12 INCHES IN DIAMETER, AND HAVE A 24 INCH BELL TO FORM THE FOOTINGS.
- C. EACH PIER WILL CONTAIN 4 EACH #4 REBAR STEEL PLACED VERTICALLY WITH #3 REBAR STEEL STRIPS.
- D. ALL PIERS WILL CONTAIN 3,000 PSI CONCRETE, WITH A 3 INCH SLUMP.


IF ADVERSE SOIL CONDITIONS SHOULD OCCUR ROCK, ETC. WE WILL INSTALL SPREAD FOOTINGS AT A DEPTH OF 4 FEET, WITH A 36 X 36 INCH SPREAD.

WE WILL LEVEL THE AFFECTED AREAS AS MUCH AS WE FEEL THE STRUCTURE WILL PERMIT. OUR MAIN INTENT WILL BE TO RAISE THE FOUNDATION ENOUGH TO HELP ELIMINATE THE STRESS CAUSED BY DIFFERENTIAL MOVEMENT, AND HELP MINIMIZE FUTURE SLAB FOUNDATION MOVEMENT WITHIN THE AFFECTED AREAS.

- 3. SHEET METAL SHIMS WILL THEN BE PLACED BENEATH THE FOUNDATION IN ORDER TO HOLD IT IN PLACE
- WE WILL INJECT LIME SLURRY SOLUTION AROUND THE PERIMETER OF THE FOUNDATION IN ORDER TO HELP MINIMIZE SOIL ACTIVITY IN AFFECTED AREAS. IF COMPANY DETERMINES THIS METHOD IS NECESSARY; COST WILL BE EXTRA.
- 5. IT IS UNDERSTOOD THAT DURING THE LEVELING PROCESS THE STRUCTURE CAN BE SUBJECTED TO VARIOUS AMOUNTS OF STRESS. THEREFORE, GULF FOUNDATION CO. WILL NOT BE RESPONSIBLE FOR ANY DAMAGE TO THE INTERIOR OR THE EXTERIOR OF THE STRUCTURE AS A RESULT OF THE LEVELING PROCESS.
- 6. UPON COMPLETION OF ALL REPAIRS, GULF FOUNDATION CO. WILL CLEAN PROPERTY AS FOLLOWS:
 - A. ALL EXCESS DIRT AND CONSTRUCTION DEBRIS WILL BE REMOVED AND THE YARD BROUGHT TO AS NEAR ORIGINAL STATE AS POSSIBLE.
 - B. WHEN SHRUBS MUST BE REMOVED, FOUNDATION CO. WILL REPLANT THEM BUT WILL NOT GUARANTEE THEIR GROWTH.
 - C. WHEN FENCING MUST BE REMOVED FOR PROPER ACCESS TO THE FOUNDATION IT WILL BE REPLACED TO AS NEAR AS ORIGINAL STATE AS POSSIBLE.

UPON COMPLETION OF ALL REPAIRS, A CERTIFIED ENGINEER'S FOUNDATION INVESTIGATION AND REPORT WILL BE SUPPLIED TO THE HOMEOWNER FOR A SPECIFIED ENGINEER'S FEE.

- 8. THE OWNERS HEREIN ACKNOWLEDGE THAT GULF FOUNDATION CO. HAS BEEN RETAINED TO PERFORM THE SERVICES AS HEREIN DESCRIBED ACCORDING TO THE TERMS AND CONDITIONS AS SET FORTH HEREIN AND GULF FOUNDATION CO. HAS NO OBLIGATION AS ABOVE DESCRIBED OTHER THAN THOSE FOUND IN THIS CONTRACT.
