LOWE SURVEY, ABSTRACT NO. 487, ANDERSON COUNTY, TEXAS, AND BEING OUT OF THE REMAINING PORTION OF A CALLED 41.40 ACRE TRACT DESCRIBED AS "TRACT ONE" IN VOLUME 2030, PAGE 854, OFFICIAL PUBLIC RECORDS OF ANDERSON COUNTY, TEXAS. SAID 14.79 ACRES OF LAND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING at a ½" iron rod found for corner, said corner being in the margin of Anderson County Road # 174, corner being in the south line of Anderson County, and the north line of Houston County, corner being along a north line of a called 47.53 acre tract conveyed to Doyle M. Shamblin and Rhonda Shamblin, and described in Volume 968, Page 254, Official Records of Houston County, Texas, corner being the southeast corner of a 2 acre tract conveyed to Guiceland Cemetery, and described in Volume 774, Page 857, Deed Records of Anderson County, Texas, for the southwest corner of the said 41.40 acre tract, the southwest corner of our subject tract, and the POINT OF BEGINNING;

THENCE N00°58'18"W., with the east line of the said 2 acre Guiceland Cemetery tract, and the west line of the 41.40 acre tract, for our west line, a distance of 160.27 feet to a 1" iron pipe found for corner, said corner being the northeast corner of the 2 acre Guiceland Cemetery tract, corner being the southeast corner of a called 6 acre tract conveyed to Kathryn Louise Baur Franks, and described in Volume 1796, Page 216, Official Public Records of Anderson County, Texas;

THENCE N00°50'27"W., with the east line of the said 6 acre Franks tract, and the west line of the 41.40 acre tract, for our west line, a distance of 761.52 feet to a *capped 3/8" iron rod found* for corner *marked* "RUST 6003", said corner being a southwest corner of a called 80.02 acre tract conveyed to the Dorene Haney Revocable Trust, and described in Document Number 2019-6358, Official Public Records of Anderson County, Texas, for the northwest corner of our subject tract;

THENCE N89°59'37"E., with a south line of the said 80.02 acre Haney Revocable Trust tract, and our north line, a distance of 752.87 feet to a *capped 3/8" iron rod found* for corner *marked "RUST 6003"*, said corner being a southeast corner of the 80.02 acre Haney Revocable Trust tract, corner being along the west line of a called 12.000 acre tract conveyed to Aaron Howard Quillin and Lindsey Quillin, and described in Document Number 2020-2364, Official Public Records of Anderson County, Texas, for the northeast corner of our subject tract;

THENCE S00°36'57"E., with the west line of the 12.000 acre Quillin tract, for our east line, at a distance of 776.92 feet passing a ½"iron rod found for reference, in all a total distance of 793.27 feet to a mag nail set for corner in asphalt road, said corner being along the Anderson/Houston County line, corner being

along a north line of the said 47.53 acre Shamblin tract, corner being the southwest corner of the 12.000 acre Quillin tract, for the southeast corner of our subject tract;

THENCE S80°15'17"W., with the county line of Anderson County and Houston County, and the approximate centerline of Anderson County Road #174, and a north line of the 47.53 acre Shamblin tract, and with the southerly line of the 41.40 acre tract, for our southerly line, a distance of 758.45 feet to the **POINT OF BEGINNING** and containing 14.79 acres of land.
