WHEREAS, on or about May 16, 2018, that instrument entitled "Amended and Restated Rules & Regulations Woodway Place Atrium Condominium Association" (the "Rules & Regs") were duly recorded under Clerk's File No. RP-2018-213056 of the Official Public Records of Real Property of Harris County, Texas; and

WHEREAS, Article IV, Section 3(c) of the Amended and Restated By-Laws of the Association ("Bylaws") provides, in pertinent part, as follows:

The Board of Managers is empowered and may establish, adopt and amend rules regulating the use, occupancy, leasing or sale, maintenance, repair, modification, and appearance of Units and common elements, to the extent the regulated action affect common elements or other Units and enforce compliance thereof. ...

WHEREAS, Section 82.102(a)(7) of the Texas Uniform Condominium Act (the "TUCA") provides the Board of Directors of a condominium unit owner's association (unless otherwise provided in its declaration) has the power to "adopt and amend rules relating to the use, occupancy, leasing, or sale, maintenance, repair, modification, and appearances of the units and common elements to the extent the regulated actions affect common elements or other units".

NOW, THEREFORE, BE IT RESOLVED that the Board of Managers hereby adopts the following amendment to the Amended and Restated Rules & Regulations Woodway Place Atrium Condominium Association:

Article XXXV titled "Procedure for Running for the Board of Managers" is hereby added to the Rules & Regs to state as follows:

XXXV. PROCEDURE FOR RUNNING FOR THE BOARD OF MANAGERS

Nominations to run for the Board of Managers (the "Board") must be submitted to the Association no later than thirty (30) days prior to the published date of the Annual Meeting.

Procedure to apply:

- a. Any Unit owner who desires to run for the Board must notify the current Board, or the Association's General Manager in writing no later than thirty (30) days prior to the published date of the Annual Meeting.
- b. It is recommended (but not required) that a candidate provide information highlighting his/her qualifications to serve on the Board.
- c. Any qualification information received by the Board shall be sent with the Annual Meeting documentation that is sent to the Unit owners.
