Field Notes Description

Being Lot 2A, Block 64, of the Town of Flatonia, Fayette County, Texas, also being part of a 0.57 acre tract conveyed from James C. Monaghan to Elaine R. Monaghan in Special Warranty Deed dated January 23, 2014 and recorded in Volume 1682, Page 585 of the Official Records of Fayette County, Texas.

Being more fully described by metes and bounds as follows:

BEGINNING: at a 5/8" iron rod with cap stamped "RPLS 6368" (Y:13,801,805.88, X:2,570,227.15), set in the north right of way line of East 6th Street, the south line of said 0.57 acre tract, and at the southeast corner of 0.24 acre tract (dually surveyed), for the southwest corner of this herein described tract, whence a 5/8" iron rod with the same transport of the southwest corner of said 0.57

acre tract bears S 88°22'41" W - 73.46 feet;

THENCE: N 01°37'19" W -74.80 feet along the southerly east line of said 0.24 acre tract and the southerly west line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at an interior corner of said 0.24 acre tract, for the southerly northwest corner of this herein described tract;

THENCE: N 88°22'41" E -25.10 feet along the easterly south line of said 0.24 acre tract and the westerly north line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at the northerly southeast corner of said 0.24 acre tract, for an interior corner of this herein described tract;

THENCE: N 01°37'19" W -50.20 feet along the northerly east line of said 0.24 acre tract and the northerly west line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set in the south line of a 25 foot alley and at the northeast corner of said 0.24 acre tract, for the northwest corner of this herein described tract;

THENCE: N 88°22'41" E -101.44 feet along the south line of said 25 foot alley and the north line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set at the northwest corner of a 0.29 acre tract conveyed to Cynthia Bosl in Volume 1912, Page 220 of the Official Records of Fayette County, Texas, for the northeast corner of this herein described tract;

THENCE: S 01°37'19" E -125.00 feet along the west line of said 0.29 acre tract and the east line of this herein described tract to a 5/8" iron rod with cap stamped "RPLS 6368" set in the north right of way line of said East 6th Street and at the southwest corner of said 0.29 acre tract, for the southeast corner of this herein described tract;

THENCE:

S 88°22'41" W -126.54 feet along the north right of way line of said East 6th Street and the south line of this herein described tract to the *POINT OF BEGINNING*, containing within these metes and bounds a 0.33 acre tract, more or less.


