

Travis, Sr., and wife, Casey R. Travis recorded in Volume 1631, Page 906 of the Official Records of Freestone County, Texas from which a 1/2" iron rod found bears S 37° 50' 20" E, 4.84 feet, another 1/2" iron rod found bears S 49° 54' 46" W, 229.05 feet and a 1/2" iron pipe found bears N 38° 30' 55" W, 19.78 feet;


