Terrasson 0.915 acre Tract III (MCCF No. 2001-039314) for the Northeast corner and POINT OF BEGINNING of the herein described tract, from which a found iron rod at the Northeast corner of said 0.915 acre Tract III bears North 10°02'00" East, 60.44 feet;

Thence South 10°02'00" West along the West line of Alford Road, a distance of 252.00 feet to an iron rod found at the Northeast corner of the Mark D. Henry 1.22 acre Tract 2 (MCCF No. 8325593) for the Southcast corner of the herein described tract;

Thence South 89°33'29" West along the North line of said 1.22 acre Tract 2, a distance of 396.00 feet to an iron rod found in the East line of the Edward L.
