# SPECIAL REQUIREMENT(S)

5 All driveways are required to start construction within 6 months and to be completed within 9 months of the date of permit. No extensions are authorized.

All development inspections are completed between 9 am and 3 pm. All cancellation requests must be submitted before 9 am on the date of your scheduled inspection

6 In order to meet the County's requirement that all culvert pipe must be ASTM C76-Class III, one of the following requirements must be met: 1. The pipe is stamped with the name of the manufacturer, the production date, and that it is ASTM C76-Class III pipe. 2. If the pipe is not stamped, it will be the responsibility of the owner to provide the name of the manufacturer and the production date. The County will verify that there are corresponding cylinder breaks that verify the strength of the RCP produced by that manufacturer for that date. If there are none, the pipe will be rejected as not meeting the requirements of ASTM C76. All culverts shall be constructed of reinforced concrete. All pre-cast conduits or pipe shall be new, tongue and grove (bell ended pipe shall not be use), reinforced Class III pipe.
