- 1. Copy of the signed Residential Sales Contract
- 2. An Astoria Residential Application Form
  - Fully completed and mailed, dropped off, or emailed to russell.chun@mms-houston.com.
  - A current version of this document can be obtained from the Management Office via email

## 3. Fees Due with Application

- Application Fee (Non-refundable)
  \$500 for the 1<sup>st</sup> person
  \$250 for each additional person 18 years or older
- Orientation Fee \$250
- Checks should be made payable to the Astoria Condominium Owners Association
- All above fees are due when the application is submitted

Upon receipt of the completed application and fees, the management office will verify all information provided, including a background check, and then notify the buyer, realtor, and/or title company. Please note that the background check can take up to five (5) business days to complete.

The Astoria will provide or provide access to the following documents as requested or needed: Resale certificate, Condominium Rules and Regulations, Declaration, Bylaws, and Insurance Summary.
