

**NOTICE TO PURCHASER**

The District has taxing authority separate from any other taxing authority, and may, subject to voter approval, issue an unlimited amount of bonds and levy an unlimited rate of tax in payment of such bonds. As of this date, the most recent rate of taxes levied by the District on real property located in the District is **\$0.258589** on each **\$100.00** of assessed evaluation. The total amount of bonds which has been approved by the voters and which have been or may, at this date, be issued is **\$0.00**, and the aggregate initial principal amounts of all bonds issued for one or more of the specified facilities of the district and payable in whole or in part from property taxes is **\$0.00**. The District has **\$13,630,000** in aggregate principal amount of maintenance notes which are payable from any lawfully available funds of the district, including the proceeds of maintenance taxes.

The District is located, in part, in the cities of Port Arthur, Nederland, Groves, and Port Neches, Texas, and their extraterritorial jurisdictions.

The purpose of this District is to provide drainage and flood control facilities and services within the District through the issuance of bonds payable in whole or in part from property taxes. The cost of these utility facilities is not included in the purchase price of your property, and these utility facilities are owned or to be owned by the District. The legal description of the property which you are acquiring is as follows:
