Road No. 2090, same being the north line of said 2.38 acre tract to a 5/8 inch iron rod with cap found in the west line of said Second Tract for the northeast corner of said 2.38 acre tract, same being the northwest corner and **POINT OF BEGINNING** of this herein described tract, from which a found 1-1/4 inch iron rod bears: South 75 degrees 00 minutes West, a distance of 2.4 feet;

THENCE North 86 degrees 06 minutes 07 seconds East, a distance of 80.38 feet with the south margin of said F.M. Road No. 2090, same being across said Second Tract and said First Tract to a point for the northerly northeast corner of this herein described tract, from which a found 1/2 inch iron rod bears: South 04 degrees 05 minutes 02 seconds East, a distance of 0.7 feet;

THENCE South 03 degrees 07 minutes 27 seconds East, a distance of 493.37 feet (called South 01 degrees East) with the west line of the remainder of said 2 acre tract, same being the east line of said First Tract to a 1-inch iron rod found in the north line of a called 3 acre tract, called Tract 1 as recorded in M.C.C.F. No. 2019006300 for the southeast corner of this herein described tract;

THENCE South 87 degrees 19 minutes 53 seconds West, a distance of 162.62 feet with the north line of said Tract 1 and the James and Patricia England Tract as recorded in M.C.C.F. No. 9018057, same being the south line of said First Tract to a 3/4 inch iron pipe found in the east line of a called 0.996 acre tract as recorded in M.C.C.F. No. 2017066470 for the southeast corner of this herein described tract;

THENCE North 01 degrees 15 minutes 36 seconds East, a distance of 37.37 feet (called North) with the east line of said 0.996 acre tract, same being the west line of said First Tract to a 1/2 iron pipe found for an angle point in the west line of this herein described tract;

THENCE North 05 degrees 28 minutes 20 seconds West, a distance of 117.25 feet (called North) with the east line of the remainder of a called 2.0 acre tract as recorded in Volume 512, Page 13, D.R.M.C.T., same being the west line of said First Tract to a 2-inch iron pipe found in the south line of a called 0.989 acre tract as recorded in M.C.C.F. No. 2000053189 for the southerly northwest corner of this herein described tract, from which a found 1-inch iron pipe bears: North 36 degrees 01 minutes West, a distance of 0.3 feet and a found 1-inch bolt bears: North 18 degrees 02 minutes East, a distance of 0.3 feet;

THENCE North 86 degrees 17 minutes 08 seconds East, a distance of 15.96 feet (called East) with the south line of said 0.989 acre tract, same being the southerly north line of said First Tract to a 1/2 inch iron pipe found for the southwest corner of said Second Tract, same being an interior corner of this herein described tract, from which a found 1/2 inch iron rod bears: North 75 degrees 49 minutes West, a distance of 0.5 feet, a found 1-inch square bolt bears: South 85 degrees 11 minutes East, a distance of 8.8 feet and a found 1-inch iron rod found bears: North 89 degrees 52 minutes West, a distance of 6.3 feet;

THENCE North 03 degrees 46 minutes 55 seconds West, a distance of 223.78 feet (called North) with the east line of said 0.989 acre tract and a called 2.0 acre tract as recorded in M.C.C.F. No. 2020059052, same being the west line of said Second Tract to a 5/8 inch iron rod found for the southeast corner of said 2.38 acre tract, same being an angle point in the west line of this herein described tract;

THENCE North 03 degrees 36 minutes 54 seconds West, a distance of 302.51 feet (called North) with the east line of said 2.38 acre tract, same being the west line of said Second Tract to the **POINT OF BEGINNING** and containing **2.10** acres.
