AMENDMENT TO RESTRICTIONS
[Rollingwood Subdivision]

This AMENDMENT TO RESTRICTIONS ("*Amendment*") is made and entered into by the undersigned owners of Lots (herein defined) to be effective as of January 1, 2005.

RECITALS

A. Pursuant to instrument executed on August 25, 1940 and recorded in the Deed Records of Harris County, Texas, in Volume 1184, Page 25, certain restrictive covenants ("*Restrictions*") were imposed against Lots 1 through 37 and Reserve A of Rollingwood, a subdivision of approximately 71.6556 acres out of the Thomas Hoskins Survey, Harris County, Texas, created by map of plat recorded in Volume 16, Page 69 of the Map Records of Harris County, Texas (the 37 lots created by such map or plat herein being collectively called the "*Lots*" and each such lot herein being called a "*Lot*").

B. The Restrictions are in full force and effect.

C. Under paragraph X of the Restrictions, the Restrictions are automatically extended for a ten (10) year period on January 1, 2005 unless by vote of the majority of the then owners of the Lots it is agreed to change the Restrictions in whole or in part.

D. The undersigned, being a majority of the owners of Lots, desire to vote to change the Restrictions as herein provided.

AGREEMENT

In consideration of the Recitals, the covenants set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned, who constitute a majority of the owners of the Lots, hereby vote and agree as follows:

1. All references in the Restrictions to "lot" or "lots" shall mean "*Lot*" or the "*Lots*", as such terms are defined in this Amendment. Each Lot is a lot under the Restrictions.

2. Paragraph A of the Restrictions is deleted in its entirety and replaced with the following:

All Lots shall be known and described as residential lots. No structures shall be erected, altered, placed or permitted to remain on any Lot other than, as to each Lot, one (1) Permitted Single Family Dwelling. As used herein, the term "*Permitted Single Family Dwelling*" shall mean a detached single-family dwelling not to exceed two and one-half stories in height and a private garage for not more than four (4) cars and other outbuildings incidental to residential use of such Lot. No Lot shall be re-platted or subdivided. No Lot shall contain more than one Permitted Single Family Dwelling regardless of whether such Lot has previously been re-platted or

subdivided (or such Lot, in violation of the restriction set forth in the immediately preceding sentence, is in the future re-platted or subdivided).

3. In the first sentence of Paragraph B of the Restrictions, the phrase "building plot" is hereby replaced with the word "Lot".

4. Paragraph F of the Restrictions is hereby deleted in its entirety.

5. In both the first sentence of Paragraph K of the Restrictions and the last sentence of Paragraph L of the Restrictions, the phrase "in the Addition" is hereby deleted.

6. As of the date hereof, the names and address of the members of the neighborhood committee referred to in the Restrictions are as follows:

Such neighborhood committee is generally known in Rollingwood subdivision as the Rollingwood Architectural Committee.

7. The Restrictions, as amended by this Amendment, will be automatically extended for a period of ten (10) years as of January 1, 2005 in accordance with paragraph X of the Restrictions.

8. The Restrictions, as amended by this Amendment, are hereby ratified in all respects.

9. The Restrictions, as amended by this Amendment, are and shall remain in full force and effect and shall inure to the benefit of and be binding upon all of the owners of Lots and upon each of their respective heirs, legal representatives, successors and assigns.

10. This Amendment may be executed in one or more counterparts.
