THENCE North 81 deg. 47 min. 58 sec. East with the westerly North line of the 5.980 acre Sullivan tract and the South right-of-way of U.S. Highway No. 84, a distance of 566.32 ft. to a concrete right-of-way monument (found) for the p.c. of a curve to the left;

THENCE in a northeasterly direction with the easterly North line of the 5.980 acre Sullivan tract, the South right-of-way of U.S. Highway No. 84 and said curve to the left, a distance of 564.57 ft. which has a radius of 5,789.58 ft. and a long chord bearing and distance of North 79 deg. 02 min. 05 sec. East – 564.35 ft. to the point of beginning and containing 5.95 acres of land.
