

AMENDMENT TO INFORMATION FORM OF

We, the undersigned, constituting a majority of the members of the Board of Directors of Harris County Municipal Utility District No. 449 (the "District"), do hereby make, execute and affirm this Amended Information Form in compliance with Texas Water Code §49.452 and §49.455 and 30 TAC §293.92. We do hereby certify as follows:

1. The most recent rate of taxes levied by the District is \$1.16 per \$100 assessed valuation.


2. The total amount of bonds, excluding refunding bonds and any bonds or any portion of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by the voters and which have been or may, at this date, be issued is \$86,960,000, of which \$4,300,000 was approved for parks and recreational facilities, and the aggregate initial principal amounts of all bonds issued for one or more of the specified facilities of the District and payable in whole or in part from property taxes is \$76,030,000.

3. The total amount of refunding bonds that have been approved by the voters and which may be (or have been) issued by the District is \$82,660,000.



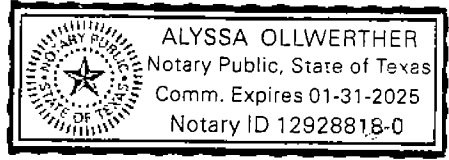




EXHIBIT A**NOTICE TO PURCHASERS**

The real property, described below, that you are about to purchase is located in the Harris County Municipal Utility District No. 449 (the "District"). The District's creation was confirmed by election on May 13, 2006. The District has taxing authority separate from any other taxing authority and may, subject to voter approval, issue an unlimited amount of bonds and levy an unlimited rate of tax in payment of such bonds. As of this date, the rate of taxes levied by the District on real property located in the District is \$1.16 on each \$100 of assessed valuation. The total amount of bonds, excluding any bonds or any portion of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by the voters and which have been or may, at this date, be issued is:

\$82,660,000 for water, sanitary sewer, drainage and flood control facilities;
\$4,300,000 for park and recreational facilities; and
\$82,660,000 for refunding bonds.

The aggregate initial principal amount of all bonds issued and payable in whole or in part from property taxes is:

\$76,030,000 for water, sanitary sewer, drainage and flood control facilities;
\$0 for park and recreational facilities; and
\$0 for refunding bonds.

The District is located in whole or in part in the extraterritorial jurisdiction of the City of Houston (the "City"). By law, the District may be annexed by the City without the consent of the District if the City complies with the requirements of Chapter 43, Texas Local Government Code, as amended, which may include voter approval. When a District is annexed, the District is dissolved.


The purpose of this District is to provide water and sewer, drainage and flood control, and park and recreational facilities and services benefitting the District through the issuance of bonds payable in whole or in part from property taxes. The cost of these utility facilities is not included in the purchase price of your property, and these utility facilities are owned or to be owned by the District and/or another governmental entity. The legal description of the property you are acquiring is as follows:


