



LEGEND Power Pole Overhead Power Wood Fence • 5.65 Elevation (Typ.)



Schrier Tract out of the ELIJAH FRANKS SURVEY, Galveston County, Texas, according to the map thereof recorded in Volume 235, Page 411 of the Galveston County Deed Records and said Tract 6-B being more particularly described be metes and bounds as follows:

COMMENCING at the intersection of the West line of said Tract No. 6 and the South right—of—way line of State Highway No. 87;

THENCE North 67°55' East, along said State Highway No. 87, a distance of 53.74 feet to the PLACE OF BEGINNING, a found 1/2 inch rod;

THENCE continuing North 67°55' East, along said State Highway No. 87, a distance of 53.74 feet, a found 1/2 inch rod;

THENCE South 23' East, at 230 feet passing a set 1/2 inch rod, continuing for a total distance of 395.8 feet to the mean high water line of the Gulf of Mexico;

THENCE South 64°03'19" West, with said mean high water line, a distance of 53.8 feet;

THENCE North 23° West, at 169.42 feet passing a set 1/2 inch rod, continuing for a total distance of 399.42 feet to the said South right—of—way line of State Highway No. 87 and the PLACE OF BEGINNING of the herein described tract, containing 0.49 acre, more or less, subject to the rights of the public beach.
