## FIRST AMENDMENT TO DECLARATION

OF

## COVENANTS, CONDITIONS AND RESTRICTIONS

In accordance with the Declaration of Covenants, Conditions and Restrictions filed of record in the Office of the County Clerk of Galveston County, Texas under Clerk's File No. 9601322, these Restrictions are hereby filed of record as the First Amendment to the Restrictions. Said Amendments are specifically outlined below as follows:

Article III, entitled Use Restrictions, Section 8 is hereby amended as follows:

Section 8. The main floor of the main structure, exclusive of open porches and garages, and exclusive of the area beneath the main floor, shall not be less than the following designated square feet of living area as outlined below:

- a) As to Lot nos. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, and 22, respectively, herein designated on the plat of the Subdivision known as RANCHO CARRIBE, the main structure shall not be less than sixteen hundred (1600) square feet of living area;
- b) As to Lot nos. 23, 24, 31, 32, 33, 34, 43, 44, 45, 46, 55, 56, 57, 58, 67, 68, 69, 70, 79, 80, and 81, respectively, herein designated on the plat of Subdivision known as RANCHO CARRIBE, the main structure shall not be less than fourteen hundred (1400) square feet of living area; and
- c) As to Lot nos. 25, 26, 27, 28, 29, 30, 35, 36, 37, 38, 39, 40, 41, 42, 47, 48, 49, 50, 51, 52, 53, 54, 59, 60, 61, 62, 63, 64, 65, 66, 71, 72, 73, 74, 75, 76, 77, 78, 82, 83, 84, 85, 86, 87, and 88, respectively, herein designated on the plat of the Subdivision known as RANCHO CARRIBE, the main structure shall not be less than twelve hundred (1200) square feet of living area.

Article III, entitled Use Restrictions, Section 9 is hereby amended as follows:

Section 9. No building shall be located nearer to the respective boundaries of the respective lots than the minimum building set-back lines as shown on the Amended Plat marked as Exhibit "A" and made a part hereof for all purposes. Any mention in the Restrictions filed of record in the Office of the County Clerk herein, shall refer to the Amended Plat attached hereto.

Article V, entitled Covenants for Maintenance Assessments, Section 8 is hereby amended as follows:

Section 8. All that part of the Property designated on the plat as Reserves A, B, C, and D and the numbered Lots in the Subdivision known as RANCHO CARRIBE, which Declarant has not sold or conveyed shall be exempt from the provisions of this Article V.

These Amendments constitute all Amendments made to the original Declaration of Covenants, Conditions, and Restrictions and are submitted in accordance with the provisions outlined for making such amendments. Said provisions require an instrument signed by not less than seventy-five (75%) of the Lot owners. The Lot Owners' signatures below constitute the minimum seventy-five percent (75%) required for such Amendment.


