WHEREAS, MHI Partnership, Ltd assigned all of its right, title and interest (whether as declarant, owner, member or otherwise) in and to the Declaration to Mag Creek Partners, LP pursuant to that certain Assignment and Assumption Agreement dated effective as of November 28, 2005 and filed in the Official Public Records of Real Property of Galveston County under Clerks File No 2006038854,

WHEREAS, Declarant, MHI Partnership, Ltd and Weekley Homes, LP are the owners of the certain property (the "Property") located in Galveston County, Texas and as more particularly described in Exhibit "A" attached hereto and incorporated herein for all purposes,

WHEREAS, ARTICLE III, Section B of the Declaration provides, in pertinent part, as follows
