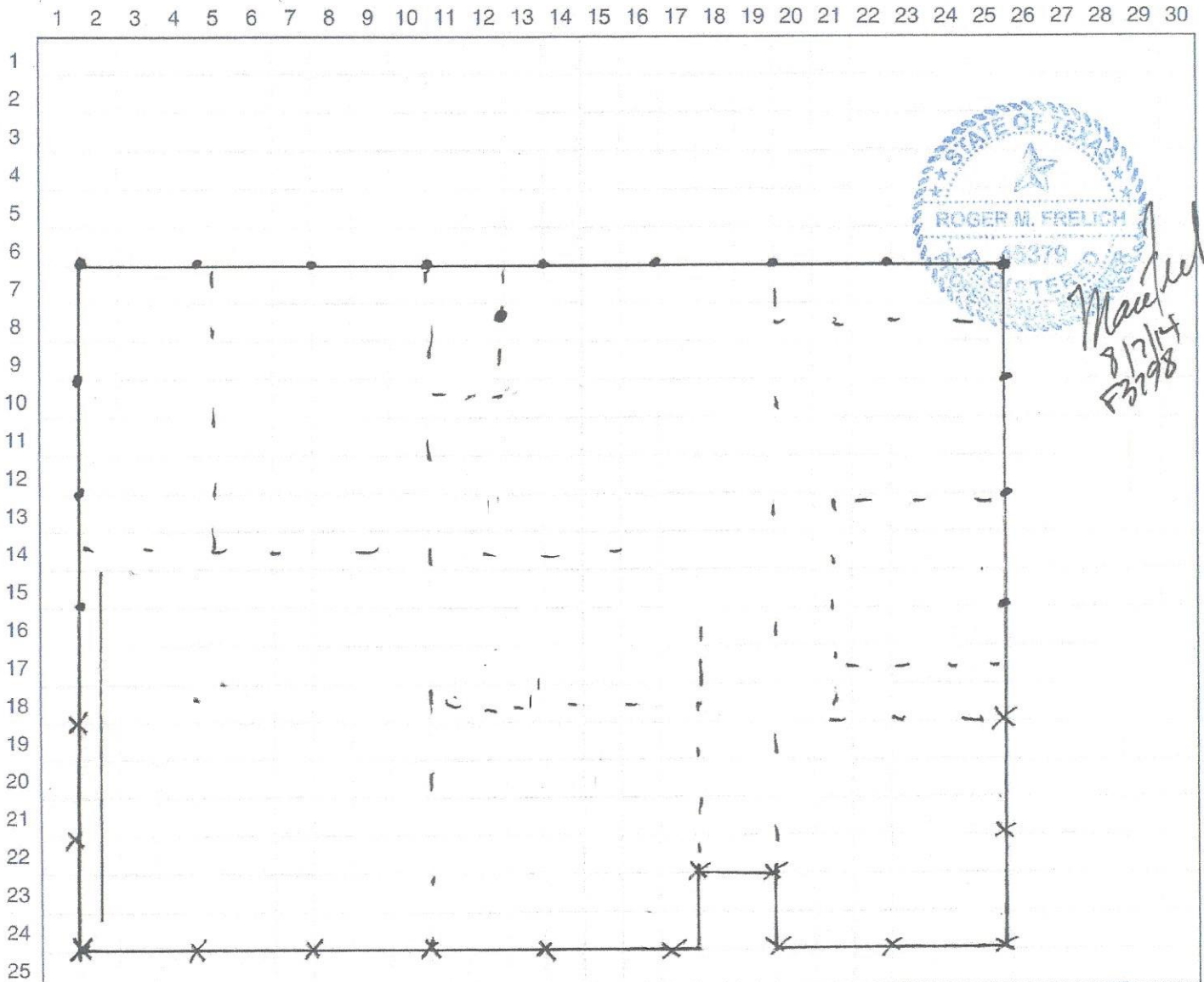

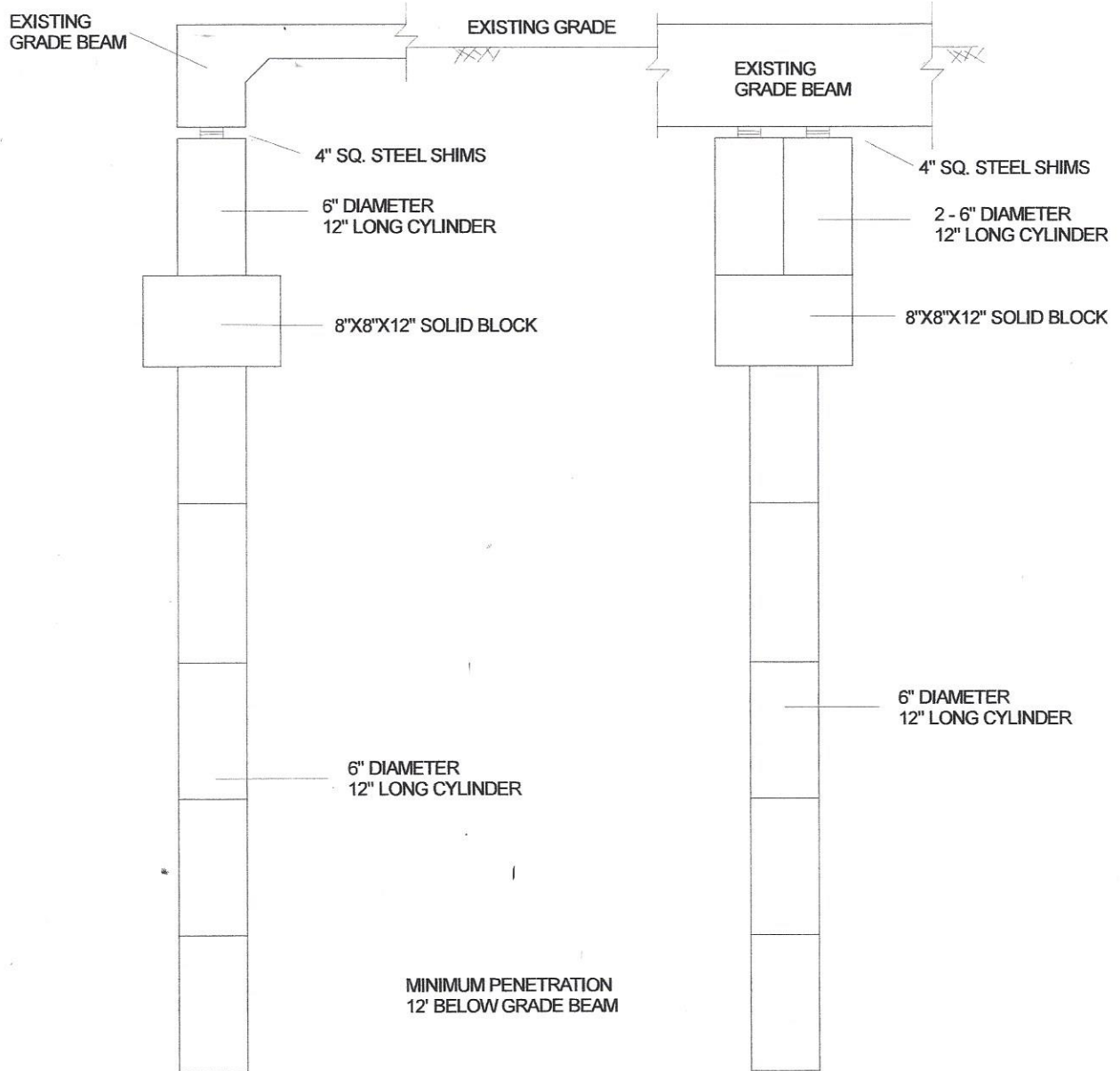

## CERTIFIED FOUNDATION SPECIALIST LIFE TIME WARRANTY

Owner recognizes that soil conditions in this area are such that future shifting may occur, particularly during periods of extended dry weather. If any re-raising of the area on which Contractor performed the work set forth herein is necessary due to such settling during the life of the structure, Contractor will re-raise settled area where Contractor's piles have been installed, without cost to the Owner.

This agreement, and the provisions of this paragraph, does not extend to any portion of the structure other than that portion upon which Contractor actually installed piles. Contractor guarantees all materials furnished by Him will be of standard quality, free from defects, and installed in good and workmanlike manner. This warranty may be transferred to a subsequent Owner of the property. In order for the transfer to be affected, written notification must be furnished along with a \$150.00 fee payable to Galli Cribbs within 30 days of closing of sale by Owner, in person or by mail.

This warranty remains in effect so long as the following provisions are satisfied:

- (1) Structure has not been altered or additions made without prior consultation with Contractor.
- (2) Structure has not suffered fire damage to any degree
- (3) Structure has not been subjected to flood damage
- (4) Structure has not been subjected to plumbing leaks above grade or below
- (5) Structure is not located on an active fault

This warranty is backed by an active claim reserve account

Upon completion of work contained herein and receipt of final payment, Contractor agrees to release said work and property from any and all claims. Should Owner fail to execute and promptly release final payment to Contractor upon final said completion, then owner agrees to all reasonable cost incurred by Contractor as a result of any collection attempts.

This agreement shall become binding only upon the execution of same by Owner and Contractor or duly appointed agent of Contractor, and same shall constitute the entire contract and Notice of Completion between Contractor and Owner.

No oral representation thereof can change or modify this warranty.
