FIRST AMENDMENT TO THE FIRST AMENDED BY-LAWS

WHEREAS, Section 209.00593(b) of the Texas Property Code provides that the board of a property owners association may amend the by-laws of the property owners' association to provide for elections to be held as required by Subsection (a);

WHEREAS, certain other newly added provisions of the Texas Property Code conflict with, and expressly void, the terms of the original By-Laws; and

WHEREAS, it is the desire of the Board of Directors to amend the By-Laws to bring the Association in compliance with the provisions of the Texas Property Code which were passed by the Texas Legislature in 2011; and

NOW THEREFORE, Article III, Section 4 is hereby AMENDED to ADD the following:

For Board of Director Elections: If quorum is not present or represented at a meeting being held for the sole purpose of election of directors, the meeting shall be adjourned, without notice other than announcement at the meeting, and immediately recalled for the sole purpose of election of directors, at which time quorum shall be all those members present whether in person or by proxy, absentee ballot, electronic ballot, or any other method of representative or delegated voting, and the person receiving the largest number of votes shall be elected.

Nothing herein is intended to alter, modify or amend the By-Laws except as specifically provided hereinabove.
