## FIELD NOTE DESCRIPTION TRACT 24 10.100 ACRES IN THE SAMUEL BLAIR SURVEY, ABSTRACT NUMBER 4, AND IN THE JOHN SCOTT SURVEY, ABSTRACT NUMBER 62 REFUGIO COUNTY, TEXAS

BEING a 10.100 acre tract of land situated in the Samuel Blair Survey, Abstract Number 4, and in the John Scott Survey, Abstract Number 62, Refugio County, Texas, being being a portion of that certain called 464.442 acre tract described in instrument to Windsor Chase, LLC, recorded under Instrument Number 2021001071 of the Official Public Records of Refugio County, Texas (O.P.R.R.C.T.), said 10.100 acre tract being more particularly described by metes and bounds as follows:

**BEGINNING** at a ½ inch iron rod with cap stamped "TPS 100834-00" set in the northwesterly margin of Jackson Road, the southeasterly line of said 464.442 acre tract for the southeasterly corner of the herein described 10.100 acre tract:

THENCE South 72°21'35" West, 285.21 feet, to a ½ inch iron rod with cap stamped "TPS 100834-00" set for the southwesterly corner of the herein described 10.100 acre tract, from which a fence corner post found for reference bears, South 72°22'34" West. 142.33 feet:

THENCE severing, over and across said 464.442 acre tract, the following two (2) courses and distances:

- 1. North 11°54'28" West. 746.45 feet, to a ½ inch iron rod with cap stamped "TPS 100834-00" set for corner:
- 2. North 27°33'44" West, 906.35 feet, to a ½ inch iron rod with cap stamped "TPS 100834-00" set in the common line between said 464.442 acre tract and those certain tracts described in instrument to Barber Ranches, LTD, recorded in Volume 52, Page 301, O.P.R.R.C.T., being the northwesterly corner of the herein described 10.100 acre tract:

THENCE North 72°15'45" East, 364.29 feet, with the common line between said 464.442 acre tract and Barber Ranches tracts, to a ½ inch iron rod with cap stamped "TPS 100834-00" set for the northeasterly corner of the herein described 10.100 acre tract:

THENCE South 17°43'45" East, 1636.13 feet, over and across said 464.442 acre tract, to the **POINT OF BEGINNING**;

CONTAINING a computed area of 10.100 acres of land within this Field Note Description.
