

A TRACT OF LAND being a part of Lot 1 of "A Replat of Campbell Site Plan", a subdivision in Galveston County, Texas according to the plat recorded in Plat Record 18, Map No. 713 in the Map Records of Galveston County, Texas, said TRACT OF LAND containing 324 square feet of land and being more particularly described by metes and bounds as follows:

BEGINNING at the easterly common corner of Lots 1 and 2 of said "Campbell Site Plan", in the West line of 20th Street, from which a found 1 inch steel pipe (1" IP) at the intersection with the North line of Avenue N-1/2 (70 foot width) bears S 16° 43' E, 87.90 feet;

THEN S 73° 17' W along the common line of Lots 1 and 2, 53.54 feet to the westerly common corner of Lots 1 and 2, in the East line of Lot 3, Campbell Site Plan;

THEN N 16° 43' W along the common line of Lots 1 and 3, 6.05 feet to a set ½ inch diameter steel reinforcement bar (½" IR);

THEN N 73° 17' E, 53.54 feet to a set 1/2" IR in 20th Street;

THEN S 16° 43' E along the common line of Lot 1 and 20th Street, 6.05 feet to the POINT OF BEGINNING, containing 324 square feet of land.
