WHEREAS. OPEN WORLD PROPERTIES, LLC, a Texas limited liability company has previously been designated as sole member of the ACC pursuant to the terms of the Declaration; and

**WHEREAS**, Section 12 of the Declaration provides that the restrictions set forth within the Declaration shall be entirety within the discretion of the ACC and the ACC may at any time change, alter, modify or discontinue the same or any part thereof without notice to or consent of the owner or owners of any portion of the Subdivision;

WHEREAS, OPEN WORLD PROPERTIES, LLC, a Texas limited liability company, has been designated sole member of the ACC pursuant to the terms of the Declaration and that certain instrument entitled Amendment to Architectural Control Committee for Yegua Hills Subdivision, dated May 19, 2022 and filed for record within the Real Property Records of Burleson County, Texas; and

WHEREAS, the ACC has determined that the Declaration and all restrictions therein included and imposed against the real property of the Subdivision are no longer needed and has determined to terminate and discontinue the Declaration and its associated restrictions in their entirety.

**NOW, THEREFORE**, in consideration of the recitals set forth above, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, notice is hereby given that, pursuant to Section 12 of the Declaration, the ACC hereby discontinues and terminates the Declaration and its associated restrictions encumbering the Subdivision in their entirety, as evidenced below by the signature and acknowledgment of, OPEN WORLD PROPERTIES, LLC, a Texas limited liability company, in its capacity as sole member of the ACC.

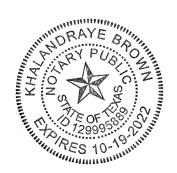
