

Field notes of a 0.207 acre tract as described in a deed recorded in File No. 180658, Official Public Records Nueces County, Texas. Said 0.207 acre tract being out of the northeast quadrant of Block 16, "Morris Addition" as shown on the plat recorded in Volume M, Page 498, Deed Records Bee County, Texas. Said 0.207 acre tract being more particularly described as follows:

COMMENCING at a 5/8" re-bar found for the west corner of Block 15, of said "Morris Addition", and in the southeast right of way of West Hutchinson Street, THENCE with the southeast right of way of West Hutchinson Street, South 62°20'57" West, a distance of 84.61 feet to a 5/8" re-bar found in the southeast right of way of West Hutchinson Street, in the northwest line of said northeast quadrant of Block 16, for the north corner of this survey, and for the POINT of BEGINNING.

THENCE with the northeast line of this survey, South 27°03'37" East, a distance of 150.04 feet to a 5/8" re-bar found in the common line of the southeast line of said northeast quadrant, and the northwest line of Allen Sugarek's southeast quadrant of Block 16, of said "Morris Addition", as described in a deed recorded in Volume 202, Page 336, Deed Records Bee County, Texas, and for the east corner of this survey.

THENCE with the common line of said Allen Sugarek's southeast quadrant, said northeast quadrant, and this survey, South 62°38'06" West, a distance of 60.08 feet to a 5/8" re-bar set in the common line of said northeast quadrant and said Allen Sugarek's southeast quadrant, and for the south corner of this survey.

THENCE with the southwest line of this survey, North 27°03'37" West, a distance of 150.04 feet to a 5/8" re-bar found in the northwest line of said northeast quadrant, in the southeast right of way of West Hutchinson Street, and for the west corner of this survey.

THENCE with the common line of the southeast right of way of West Hutchinson Street, said northeast quadrant, and this survey, North 62°38'06" East, a distance of 60.08 feet to the POINT of BEGINNING of this tract, and containing 0.207 acres of land, more or less.
