The most recent rate of taxes levied by the district on real property located in the district is \$0.363 on each \$100 of assessed valuation. The district may exercise the authority without holding an election on the matter. As of this date, the amount of the standby fee is \$60 per year per lot. An unpaid standby fee is a personal obligation of the person that owned the property at the time of imposition and is secured by a lien on the property. Any person may request a certificate from the district stating the amount, if any, of unpaid standby fees on a tract of property in the district.

The purpose of this district is to provide water, sewer, drainage, or flood control facilities and services within the district through the issuance of bonds payable in whole or in part from property taxes. The cost of these utility facilities is not included in the purchase price of your property, and these utility facilities are owned or to be owned by the district.
