FLOWERS AND ARLENE M. FLOWERS BY DEED RECORDED IN VOLUME 704, PAGE 971 OF THE OFFICIAL PUBLIC RECORDS OF TYLER COUNTY. SAID 0.493 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING AT A 1/2" IRON ROD FOUND ON THE EAST RIGHT OF WAY OF F.M. HIGHWAY 256 FOR NORTHWEST CORNER OF THE FLOWERS 1.092 ACRES AND OF THE HEREIN DESCRIBED TRACT, SAME BEING THE WEST CORNER OF THE FAYE RATCLIFF TRACT, BEING THE RESIDUE OF A 5.33 ACRE TRACT DESCRIBED IN VOLUME 183, PAGE 168 OF THE OFFICIAL PUBLIC RECORDS;

THENCE S 55°00'00"E 148.89 FT., WITH THE SOUTH LINE OF THE RATCLIFF TRACT AND THE NORTH LINE OF THE FLOWERS 1.092 ACRE TRACT, TO A 1/2" IRON ROD SET FOR THE NORTHEAST CORNER OF THIS TRACT;

THENCE S 37°14'02"W 149.34 FT. TO A 1/2" IRON ROD SET FOR THE SOUTHEAST CORNER OF THIS TRACT, SAME BEING THE NORTHEAST CORNER OF THE JEFFREY PAUL BROWN 0.307 ACRE TRACT AS RECORDED AND DESCRIBED IN VOLUME 1152, PAGE 537 OF THE OFFICIAL PUBLIC RECORDS;

THENCE N 51°22'51"W 144.44 FT., WITH THE NORTH LINE OF THE BROWN 0.307 ACRE TRACT, TO A 1/2" IRON ROD SET FOR THE NORTHWEST CORNER OF SAME AND THE SOUTHWEST CORNER OF THIS TRACT LOCATED ON THE EAST RIGHT OF WAY OF F.M. HIGHWAY 256;

THENCE NORTHEASTERLY 140.25 FT. ALONG THE ARC OF A CURVE TO THE RIGHT IN THE HIGHWAY RIGHT OF WAY LINE, HAVING A CENTRAL ANGLE OF 8°47'00", A RADIUS OF 914.93 FT. AND A CHORD BEARING N 35°26'34"E 140.12 FT. TO THE PLACE OF BEGINNING AND CONTAINING WITHIN THESE BOUNDS 0.493 OF AN ACRE OF LAND.
