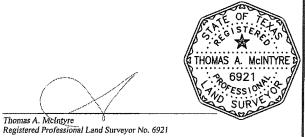

BEING a 0.998 acre tract of land, situated in the Redding Roberts Survey, Abstract Number 457 and in the J.C. Simmons Survey, Abstract Number 651, Montgomery County, Texas, being all that same called 1.000 acre tract in instrument to Shelli K, Shely and Denise C. Shely, recorded under Clerk's File Number 2004098175 of the Official Property Records of Montgomery County, Texas (O.P.R.M.C.T.), said 0.998 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a ½ inch iron rod with cap found in the southeasterly margin of South Williams Road, for the easterly common north corner of said 1.000 acre tract and the remainder of that certain called 1.59 tract described as Lot 45 of Groceville Estates (unrecorded subdivision) now or formerly in instrument to Edenia Oliver, recorded under Clerk's File Number 8016930 of the Real Property Records of Montgomery County, Texas (R.P.R.M.C.T.), being the northerly corner of that herein described 0.998 acre tract, from which a ½ inch iron rod found for the westerly corner of that certain called 0.423 acre tract described in instrument to Ray Shely and Betty Shely, recorded under Clerk's File Number 99060272, R.P.R.M.C.T., bears North 56°33'02" East, 31.95 feet, said POINT OF BEGINNING, having a Texas State Plane Coordinate value of N: 10,134,609.74, E: 3,875,729.42, Texas Central Zone, (4203), grid measurements;

THENCE South 33°18'39" East, 267.73 feet, with the southwesterly line of said remainder of 1.59 acre tract and a southwesterly line of the remainder of that certain called 10.0214 acre tract described in instrument to Ule "Ray" Shely and Betty S. Shely, recorded under Clerk's File Number 2004127666, O.P.R.M.C.T., common to the northeasterly line of said 1.000 acre tract, to a ½ inch iron rod found (bent) for the easterly common south corner of said 1.000 acre tract and said remainder of 10.0214 acre tract, being the southerly corner of the herein described 0.999 acre tract;

THENCE South 56°38'59" West, 162.16 feet, with a common line between said 1.000 acre tract said remainder of 10.0214 acre tract, to a ½ inch iron rod found (bent) for the westerly common south corner of same, being the westerly corner of the herein described 0.999 acre tract;

THENCE North 33°24'14" West, 267.75 feet, with a northeasterly line of said remainder of 10.0214 acre tract, a northeasterly line of said remainder of 1.59 acre tract, common to the southwesterly line of said 1.000 acre tract, to a ½ inch iron rod found for westerly common north corner of said 1.000 acre tract and said remainder of 1.59 acre tract, being the northwest corner of the herein described 1.000 acre tract;

THENCE North 56°39'28" East, 162.60 feet, with the southeasterly margin of said South Williams Road, the northwesterly line of said 1.000 acre tract, to the **POINT OF BEGINNING** and containing a computed area of 0.998 acres of land within this Field Note Description.
