"FURTHER, WE, DO HEREBY DEDICATE FOREVER TO THE PUBLIC A STRIP OF LAND
A MUNIOUM OF FIFTEEN (15") FEET WOSE ON EACH SIDE OF THE CENTERLINE OF ANY AND ALL GULLIES, RAYMES,
DRAWS, SLOUGHS OR OTHER NATURAL DRAWAGE COURSES LOCATED IN SAID TRACT OF LAND, AS EASEMENTS
FOR DRAWAGE PURPOSES, GIVING WASHINGTON COUNTY AND/OR OTHER PUBLIC AGENCY THE RIGHT TO ENTER
UPON SAID EASEMENT AT ANY AND ALL TIMES FOR THE PURPOSE OF CONSTRUCTION AND/OR MAINTAINING
DRAWAGE WORK AND/OR STRUCTURE."

FURTHER, ALL OF THE PROPERTY SUBDIVIDED IN THE FORECOING MAP SHALL BE RESTRICTED IN ITS USE, WHICH RESTRICTIONS SHALL RUN WITH THE TITLE OF THE PROPERTY, AND SHALL BE ENFORCEABLE, AT THE OPTION OF WASHINGTON COUNTY BY WASHINGTON COUNTY OR ANY CITIZEN THEREOF, BY MAJINGTON AS FOLLOWS:

(1.) THE DRAINAGE OF SEPTIC TANKS INTO ROAD, STREET, ALLEY OR OTHER PUBLIC DIVIDENCE, SHE'RE DIRECTLY, IS STRICTLY PROHIBITED.

(2.) DRAINAGE STRUCTURES UNDER PRIVATE DRINEWAYS SHALL HAVE A NET DRAINAGE OPENING AREA OF SUFFICIENT SIZE TO PERMIT THE FREE FLOW OF WATER WITHOUT BACKWATER.

FURTHER, WE DO HEREBY DECLARE THAT ALL PARCELS OF LAND DESIGNATED AS LOTS ON THIS PLAT ARE ORIGINALLY INTENDED FOR THE CONSTRUCTION OF RESIDENTIAL DWELLING UNITS THEREON AND SHALL BE RESTRICTED FOR SAME UNDER THE TERMS AND CONDITIONS OF SUCH RESTRICTIONS FILED SEPARATELY, UNLESS OTHERWISE NOTED.
