

# NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

## SOUTHERN MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT 831 Appomattox Dr. Spring, TX 77380 -VICKSBURG, BLOCK 6, LOT 22

The real property that you are about to purchase is located in Southern Montgomery County Municipal Utility District and may be subject to district taxes or assessments. The district may, subject to voter approval, impose taxes and issue bonds. The district may impose an unlimited rate of tax in payment of such bonds.

The current rate of the district property tax is \$0.16 on each \$100 assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters and excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by voters are:

- \$21,550,000 for water, sewer, and drainage facilities;
- \$0.00 for road facilities; and
- \$0.00 for parks and recreational facilities.

The aggregate initial principal amounts of all such bonds issued are:

- \$18,230,000 for water, sewer, and drainage facilities;
- \$0.00 for road facilities; and
- \$0.00 for parks and recreational facilities.

Portions of the district are located wholly or partly in the extraterritorial jurisdictions of (i) the City of Oak Ridge North, or (ii) the City of Houston, Texas. Texas law governs the ability of a municipality to annex property in the municipality’s extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved. Further, portions of the district are located wholly or partly within the corporate boundaries of the City of Oak Ridge North. The municipality and the district overlap, but may not provide duplicate services or improvements. Property located in the municipality and the district is subject to taxation by the municipality and the district.

The district has entered into a strategic partnership agreement with the City of Houston. This agreement may address the timeframe, process, and procedures for the municipal annexation of the area of the district located in the municipality’s extraterritorial jurisdiction.

The purpose of the district is to provide water, sewer, drainage, flood control, or other types of facilities and services. The cost of district facilities is not included in the purchase price of your property.
