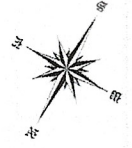

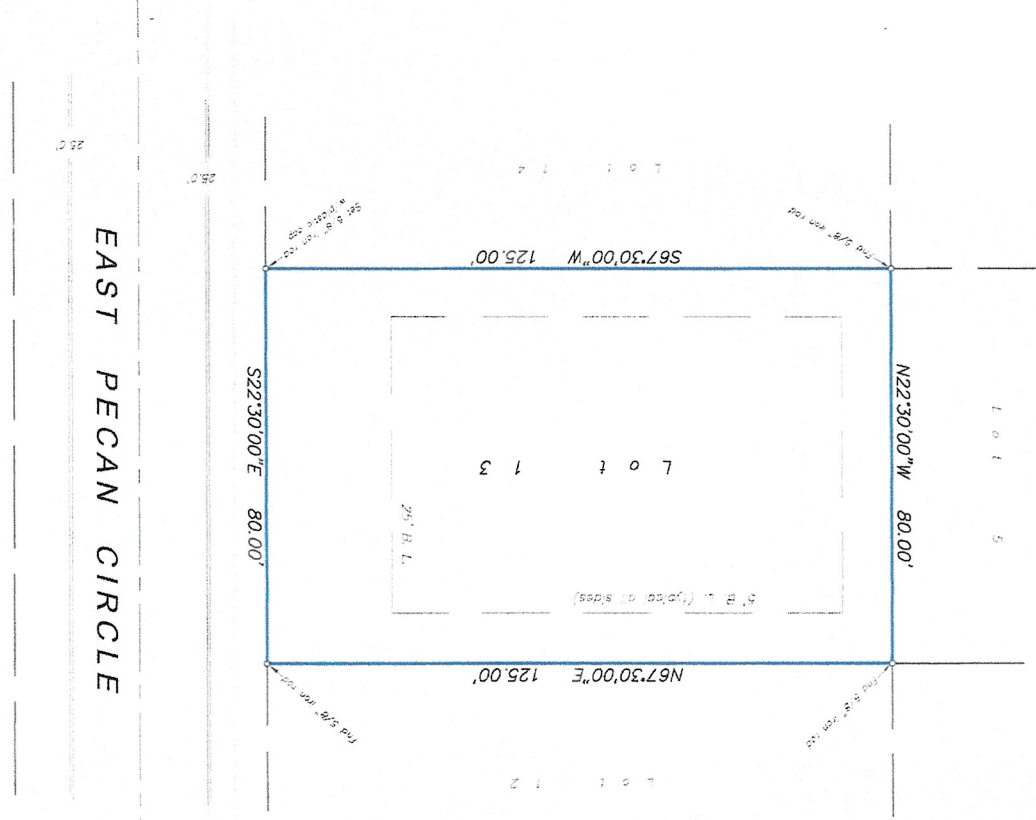
PLAT OF SURVEY OF
