BEING an 18.778 acre tract of land situated in the Jacob Eberley Survey, Abstract Number 196, and in the John Wilkerson Survey, Abstract Number 630, Montgomery County, Texas, being a portion of that certain called 24.950 acre tract described in instrument to Sara McDonald, recorded under Clerk's File Number 2016050963, of the Official Public Records of Montgomery County, Texas (O.P.R.M.C.T.), said 18.778 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a $1 / 2$ inch iron rod found in the northwesterly margin of Seven Coves Road, for the common easterly corner of said 24.950 acre tract and that certain called 10.000 acre tract described in instrument to John Pamer Sebastian and Gwyndolen Sebastian, recorded under Clerk's File Number 2022097041, O.P.R.M.C.T., being the southeasterly corner of the herein described 18.778 acre tract, said POINT OF BEGINNING having a Texas State Plane Coordinate value of $\mathbf{N} \mathbf{1 0} \mathbf{1 0 1 4 4 , 3 1 2 . 2 2}, \mathbf{E} \mathbf{3 , 8 3 9 , 5 0 5 . 0 2}$, Central Zone (4203), grid measurements;

THENCE South $86^{\circ} 36^{\prime} 08^{\prime \prime}$ West, $1,186.73$ feet, with the common line between said 24.950 acre tract and said 10.000 acre tract, to a $1 / 2$ inch iron rod found in the easterly margin of Farrell Road, for the common westerly corner of said 24.950 acre tract and said 10.000 acre tract, being the southwesterly corner of the herein described 18.778 acre tract;

THENCE with the easterly margin of said Farrell Road, the westerly line of said 24.950 acre tract, the following four (4) courses and distances;

1. North $04^{\circ} 42^{\prime} 39^{\prime \prime}$ West, 182.51 feet, to $5 / 8$ inch iron rod with cap found for corner;
2. North $01^{\circ} 25^{\prime} 52^{\prime \prime}$ West, 59.99 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" set for corner;
3. North $00^{\circ} 188^{\prime} 27^{\prime \prime}$ West, 456.59 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS $100834-00$ " set for corner;
4. North $03^{\circ} 03^{\prime} 18$ " West, 35.91 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS $100834-00$ " set for the northwesterly corner of the herein described 18.778 acre tract, from which a $1 / 2$ inch iron rod found for reference bears, North $03^{\circ} 03^{\prime} 18^{\prime \prime}$ West, 289.78 feet;

THENCE severing over and across said 24.950 acre tract the following seven (7) courses and distances;

1. South $86^{\circ} 32^{\prime} 30$ " East, 80.06 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS $100834-00$ " set for corner;
2. North $88^{\circ} 52^{\prime} 48^{\prime \prime}$ East, 58.58 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" set for corner;
3. South $82^{\circ} 39^{\prime} 09$ " East, 63.60 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" set for corner;
4. South $69^{\circ} 54^{\prime} 06^{\prime \prime}$ East, 94.07 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" set for corner;
5. South $78^{\circ} 15^{\prime} 45$ " East, 74.26 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS $100834-00$ " set for corner;
6. South $64^{\circ} 32^{\prime} 26^{\prime \prime}$ East, 93.26 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" set for corner;
7. South $87^{\circ} 55^{\prime} 28^{\prime \prime}$ East, 530.01 feet, to a $1 / 2$ inch iron rod found for a common corner of said 24.950 acre tract and that certain called 15.5382 acre tract described in instrument to Wes Schubert and Stephanie Schurbert, recorded under Clerk's File Number 2012085128, O.P.R.M.C.T., being a northerly corner of the herein described 18.778 acre tract, from which a $1 / 2$ inch iron rod found for reference bears, North $34^{\circ} 57^{\prime} 43$ " West, 585.99 feet;

THENCE South $76^{\circ} 35^{\prime} 33^{\prime \prime}$ East, 585.53 feet, with the common line between said 24.950 acre tract and said 15.5382 acre tract, to a $1 / 2$ inch iron rod found in the northwesterly margin of said Seven Coves Road, for the common easterly corner of said 24.950 acre tract and said 15.5382 acre tract, being the most easterly corner of the herein described 18.778 acre tract;

THENCE South $39^{\circ} 44^{\prime} 11^{\prime \prime}$ West, 532.73 feet, with the northwesterly margin of said Seven Coves Road, the southeasterly line of said 24.950 acre tract, to the POINT OF BEGINNING and containing a computed area of 18.778 acres of land within this Field Note Description.
