Bridges, recorded in Instrument Number No. 20211772 of the Official Records of Houston County, which a 30 foot road easement more particularly described by metes and bounds as follows:

BEGINNING on a ½ inch iron rod found for the North East corner of this easement and a North East corner of the above said 313.139 acres tract, same being on or near the North East survey line of the B.O. HENDRIX SURVEY, A-1197, and the South West line of the J.C. JEFFREY SURVEY, A-647, also being on the North Side of C.R. No. 2300;

BEGINNING on a 3/8 inch iron rod found for the North, North East corner of this 35.000 acres tract, being a North, North West corner of the original 313.1396, also being a West corner of a called 77.00 acres tract, deeded to Jason and Brandon Bridges recorded in Doc. No. 1603011 of the Official Records of Houston County, and also being on or near the North Boundary line of Houston County and the South Boundary line of Anderson County;

THENCE S 25 deg. 56 min. 19 sec. E, 375.44 feet to a ½ inch iron rod found for corner, being a East corner of this said 35.000 acres tract and being the North East corner of a called 22.22 acres tract, deeded to Ricky L. Bridges recorded in Doc. No. 0305150 of the Official Records of Houston County;

W, 1055.19 feet to a ½ inch iron rod set for corner, being the South West corner of this said 35.000 acres tract, and being a North West line of the original 313.1346 acres tract, and also being in a East line of a called 166.76 acres tract, deeded to Wilbur Bridges, recorded in Doc. No. 0004439, of the Official Records of Houston County;
