

All that certain tract or parcel of land containing 48.630 acres situated in the Fayette County School Land Survey, A-182, in Fayette County, Texas, being part of that tract originally described as 96.13 acres ("First Tract") and all of that tract described as 2-1/2 acres ("Second Tract") in a deed from Annie Synnott to Doris Lidiak, et al, dated August 4, 2010 and recorded in Volume 1531, Page 10 of the Official Records of Fayette County, said 48.630 acre tract being more particularly described by metes and bounds as follows:

Beginning at a 1/2" iron rod set at the location of a 1/2" iron rod found in 1997 survey in the North line of "Lidiak Road" (County maintained public roadway) for the Southwest corner of the (called) 48.885 acre Geraldine Dvorak tract (Vol. 1215, Pg. 65 F.C.O.R.), the Southeast corner of said 96.13 acre Lidiak, et al, tract, the Southeast corner of the tract herein described and the **PLACE OF BEGINNING**, said point having a coordinate value of North = 13,848,698.44 feet and East = 2,635,402.64 feet according to the Texas State Plane Coordinate System - South Central Zone - NAD 83(2011);

Thence South 87 degrees 38 minutes 23 seconds West, 1,022.41 feet along said North line of "Lidiak Road" and South line of said (called) 96.13 acre Lidiak, et al, tract to a 1/2" iron rod set for the Southwest corner of the tract herein described;

Thence North 02 degrees 01 minute 29 seconds West, departing said road line and severing said 96.13 acre Lidiak, et al tract, 2,074.41 feet to a 1/2" iron rod set in the common line between said 93.61 acre Lidiak, et al, tract and the (called) 101.85 acre Gerald Schmidt tract (Vol. 994, Pg. 44 F.C.D.R.) for the Northwest corner of the tract herein described;

Thence North 87 degrees 32 minutes 29 seconds East, 1,019.10 feet along the common line between said 96.13 acre Lidiak, et al, tract, said 2-1/2 acre Lidiak, et al, tract and the (called) 101.85 acre Gerald Schmidt tract to a 1/2" iron rod set for the original common corner of said 2-1/2 acre Lidiak, et al, tract, said Schmidt tract, the (called) 99.5 acre Rodney Bell tract (Vol. 1217, Pg. 559 F.C.O.R.) and the (called) 48.895 acre Geraldine Dvorak tract (Vol. 1215, Pg. 65 F.C.O.R.), also being the Northeast corner of the tract herein described, from which 1/2" iron rods found bear North 02 degrees 06 minute 59 seconds West, 2,107.96 feet and North 87 degrees 32 minutes 29 seconds East, 18.19 feet;

Thence South 02 degrees 06 minutes 59 seconds East, 2,076.15 feet along the common line between said Lidiak, et al, tract an said Dvorak tract to the PLACE OF BEGINNING and containing 48.630 acres.
